Specific clarification on these 45 sites can be found in Addendum 7, Table 007-1.</p> <p>As indicated in the RFP and previous Addenda, all data provided are estimates only for reference purposes. The information provided represents estimates based on a recent snapshot of data for which current state is subject to frequent change.</p> <p>Addendum 007 provides clarification and Addendum 6 should be considered the most current data.</p>
2	Can you provide information on the set types you have in service by location – it is unclear if the lines in service by site are digital Centrex or analog lines?	<p>The Province does not have this information readily available but is actively trying to address this request.</p> <p>The Province will provide a future addendum to finalize the response to this question.</p>
