2022 TOURISM PEI PUBLICATIONS PRINTING

Tourism PEI is producing promotional materials for the 2022 market year including the Prince Edward Island *Visitor's Guide* and *Guide de l'Île*. Specifications for each of these publications are outlined on page two and are to be priced separately, with the contract for each awarded separately. The printing deadline for the *Visitor's Guide* is March 15, 2022. *Guide de l'Île* printing deadline is April 21, 2022. **Prices quoted are to be valid until May 1, 2022.** Tourism PEI will not accept changes to quotations submitted (except for paper stock increases which require 60-day notice with correspondence from the paper mill).

Quality is important for Tourism PEI publications and selection of the printer(s) is not based solely on price; although price is a big factor in the decision. Lowest, or any bid, will not necessarily be accepted. Note that printing of all publications as specified is on FSC Certified stock. Prior to selection of printer(s), details concerning availability and suitability of specified paper stocks, production scheduling and final artwork requirements will be finalized. If using subcontractors, please specify.

If applicable, in your proposal include if any discounts will be offered for printing both the *Visitor's Guide* and *Guide de l'Île*.

Please use the attached Pricing Sheet for quoting (page three). List shipping charges separately. Shipping is split between two destinations in Charlottetown, PEI. Carton costs are to be included in quote, not as part of shipping charges. Tourism PEI will only accept press overruns of 1% over specified quantity.

Because of the current situation with Covid-19 restrictions and the uncertainty for the 2022 market year, Tourism PEI is printing lower than usual initial quantities of the *Visitor's Guide* and *Guide de l'Île* with the intention of printing a second run of both publications (if required). In your proposal please state how your company would handle the production details and the cost to reprint these two publications (if a second print run is required for one or both publications). Quantities for possible second print runs will not be determined until later in 2022.
