PUBLIC HEALTH ACT

**NOTIFIABLE DISEASES AND CONDITIONS AND
COMMUNICABLE DISEASES REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated March 10, 2026.)

Pursuant to section 72 of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30.1, Council made the following regulations:

1. **Subclause 1.1(1)(m)(i) of the *Public Health Act* Notifiable Diseases and Conditions and Communicable Diseases Regulations (EC560/13) is revoked and the following substituted:**
 - (i) alveolar echinococcosis,
 - (i.1) anaplasmosis,

2. **These regulations come into force on March 21, 2026.**

EXPLANATORY NOTES

SECTION 1 adds alveolar echinococcosis to the list of vector-borne or other zoonotic diseases, which are prescribed as notifiable diseases or conditions.

SECTION 2 provides for the commencement of these regulations.

1. **Section 2 of the *Public Health Act* Swimming Pool and Waterslide Regulations (EC93/01) is amended by the addition of the following after clause (a):**
 - (a.1) pools at tourism establishments, as defined in the *Tourism Industry Act* R.S.P.E.I. 1988, Cap. T-3.3, with not more than one unit of temporary accommodation for guests;
2. **These regulations come into force on March 21, 2026.**

EXPLANATORY NOTES

SECTION 1 exempts pools located at one-unit tourism establishments from the application of these regulations.

SECTION 2 provides for the commencement of these regulations.
