**REAL PROPERTY ASSESSMENT ACT
REGULATIONS
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated March 24, 2026..)

Pursuant to subsection 35(1) of the *Real Property Assessment Act* R.S.P.E.I. 1988, Cap. R-4, Council made the following regulations:

1. **Subsection 1(1) of the *Real Property Assessment Act* Regulations (EC490/72) is amended**
 - (a) **in clause (b),**
 - (i) **by the revocation of subclause (iii) and the substitution of the following:**
 - (iii) the acreage of the real property assessed,
 - (iii.1) the location and civic address of the real property assessed,
 - (ii) **in subclause (iv), by the deletion of the word “address” and the substitution of the words “address of the person”;**
 - (iii) **by the revocation of subclause (x) and the substitution of the following:**
 - (x) the municipal code number or fire district code number, as the case may be,
 - (iv) **in subclause (xiii), by the deletion of the word “and” after the comma, and**
 - (v) **by the addition of the following after subclause (xiv):**

-
- (xv) the total taxable assessment of commercial, non-commercial, residential, farm assessment, and farm use assessment, as the case may be, in a municipality, fire district or in the province, and
 - (xvi) the total market assessment of commercial, non-commercial, residential, farm assessment, and farm use assessment, as the case may be, in a municipality, fire district or in the province;
- (b) **by the revocation of clause (c) and the substitution of the following:**
- (c) “**assessment list**” means a list or an electronic file of all properties in a municipality or fire district, as the case may be, that contains all of the information specified in clause (b) in relation to those properties, and the number of the municipality or fire district, as the case may be;
- (c) **by the addition of the following after clause (c):**
- (c.1) “**fire district**” means a fire district as defined in the *Fire Safety Act* R.S.P.E.I. 1988, Cap. F-11.1;
 - (c.2) “**municipality**” means a municipality as defined in the *Municipal Government Act* R.S.P.E.I. 1988, Cap. M-12.1;
2. **Subsections 8(2) and (3) of the regulations are revoked and the following substituted:**
- Inspection of assessment list for municipality**
- (2) The assessment list for a municipality shall be made available to the office of the Chief Administrative Officer of that municipality, and in the event that the municipality does not make the assessment list available to the public, the electronic version of that assessment list shall be made available to the public through the Real Property Assessment Office.
- Inspection of assessment list for fire district**
- (3) The assessment list for a fire district shall be made available to the fire district committee for that fire district, and the electronic version of that assessment list shall be made available to the public through the Real Property Assessment Office.
- Publication of assessment roll information**
- (4) The Minister may publish any portion of the assessment roll, except the information specified in subclauses 1(1)(b)(iii.1) and 1(1)(b)(iv), in the form and manner the Minister considers appropriate.

-
- 3. Subsection 9(2) of the regulations is revoked.**
- 4. (1) Subsection 14(1) of the regulations is revoked and the following substituted:**
- 14. Right to access to information**
- (1) Persons employed in the Assessment Services Section of the Department of Finance and Affordability shall have access to individual selling prices obtained from affidavits, and this information may be communicated to any person.
- (2) Subsection 14(2) of the regulations is amended**
- (a) **by the revocation of clause (a) and the substitution of the following:**
- (a) a municipality, in respect of the municipality's own assessment information;
- (b) **in clause (c), by the deletion of the word "and" after the semicolon;**
- (c) **in clause (d), by the deletion of the period and the substitution of the words "; and"; and**
- (d) **by the addition of the following after clause (d):**
- (e) the Department of Housing and Communities.
- 5. The regulations are amended in the following provisions by the deletion of the word "Finance" and the substitution of the words "Finance and Affordability":**
- (a) **subsection 8(1);**
- (b) **subsection 14(2).**
- 6. (1) Form 1 of Schedule A to the regulations is revoked and the Form 1 as set out in the Schedule to these regulations is substituted.**
- (2) Form 3 of Schedule A to the regulations is revoked.**

7. **These regulations come into force on April 4, 2026.**

EXPLANATORY NOTES

SECTION 1 amends subsection 1(1) of the *Real Property Assessment Act* Regulations (EC490/72) to add definitions of “fire district” and “municipality” and to update the specified existing definitions to reflect current practices.

SECTION 2 revokes subsections 8(2) and (3) of the regulations and substitutes new subsections 8(2), (3) and (4). The new subsections 8(2) and (3) continue to require assessment lists to be provided to municipalities and fire districts, but the language is updated to reflect current practices. New subsection 8(4) authorizes the Minister to publish any portion of the assessment roll in the form and manner the Minister considers appropriate.

SECTION 3 revokes subsection 9(2) of the regulations. This provision applied only to the 2020 taxation year and is now spent.

SECTION 4 amends subsection 14(1) of the regulations to eliminate the list of specified entities and clarify that it is meant to apply generally. It also amends subsection 14(2) of the regulations to clarify that the reference to information that may be made available to a municipality means the municipality’s own assessment information, and to add the Department of Housing and Communities to the list of entities to which property assessment information generally may be made available.

SECTION 5 amends the specified provisions to update the name of the Department of Finance and Affordability.

SECTION 6 revokes the current Form 1 of Schedule A to the regulations and substitutes an updated Form 1 there. The section also revokes Form 3 of Schedule A to the regulations, which is not needed. In future, the Notice of Appeal will be in the form approved by the Minister, as required by the *Real Property Assessment Act*.

SECTION 7 provides for the commencement of the regulations.
