

# PEI Universal EV Incentive Program

Updated September 5, 2025



## **TERMS & CONDITIONS - PEI Universal EV Incentive Program**

The Prince Edward Island Universal EV (UEV) Incentive Program is intended to encourage and accelerate clean energy vehicle deployment and technology innovation within Prince Edward Island. The UEV Incentive Program is administered and implemented through the Department of Environment, Energy and Climate Action (EECA) and the Department of Transportation and Infrastructure (DTI).

The program provides incentives for Islanders who purchase (a new or used) or lease (a new) Battery Electric Vehicle (BEV) or a Plug-in Hybrid Electric Vehicle (PHEV).

The purchaser/lessee of the vehicle(s) must be a PEI resident or a non-profit, business, public agency, or entity operating or registered in PEI (including Island municipalities, First Nations, Indigenous Organizations, and organizations that support Indigenous Peoples, but excluding provincial, crown, and federal government agencies).

Businesses that are active in the corporate registry, Island municipalities, First Nations, Indigenous Organizations, organizations that support Indigenous Peoples, and non-profit organizations qualify for five (5) incentives per calendar year. Businesses that are inactive for non-payment in the Business Registry will be ineligible for the EV Incentive.

The purchase/lease date must be on April 1st 2021, or after to be eligible for the incentive.

The following documents must be filled out accurately and submitted to Access PEI in a timely manner:

- Proof that each sale / lease of an eligible UEV Incentive Program was made to a PEI resident (or PEI business operating in PEI with a valid business license or to a public agency in PEI).

- A copy of the sales or lease contract signed by all parties with an itemization of credits, discounts, and incentives received, if applicable.
- Copy of PEI driver's license and copy of vehicle registration.
- An EV Incentive Application signed by the purchaser/lessee (and dealership if purchased on-island).

Consignment sales are ineligible for an incentive.

The Government of Prince Edward Island (herein "Government") makes no representation or warranties of any kind, express or implied, regarding the suitability of the product being provided herein. Under no circumstances will Government be liable for any loss, damage, expense, incidental or consequential damages of any kind arising in connection with the use, or the inability to use, the product provided.

The purchaser/lessee shall indemnify and hold harmless Government, its agents, representatives and employees from and against all claims, demands, losses, writs, damages, actions, suits or proceedings of every nature and kind whatsoever arising out of or resulting from the provision of the rebate herein, the use of the vehicle being purchased.

## To qualify for an incentive vehicles must meet the following requirements:

Eligible vehicles must align with the standards established by the Transport Canada iZEV program (currently paused). Although a formal eligibility list is not currently available, applicants are encouraged to consult with their dealership to confirm vehicle eligibility.

Incentive amounts may differ from those previously offered under the federal program. Please refer to the Government of PEI website for the most up-to-date rebate amounts.



For used vehicles: Vehicles must have a sticker price of \$70,000 or less and must not be older than 7 model years old. Note- this stipulation does not apply to converted EVs purchased from Upcycle Green Technology in PEI.

The Department of Transportation and Infrastructure or the Department of Environment, Energy and Climate Action may request that a vehicle manufacturer provide a written statement declaring whether or not the vehicle is capable of highway operation. A vehicle will be presumed not capable of operation on the highway if any one of the following circumstances apply:

- the vehicle is a low-speed vehicle;
- the vehicle is prohibited by law from being operated on the highway or is only capable of limited operation on the highway;
- the manufacturer has required, or will require, the purchaser or lessee to sign an agreement that limits, or prevents, the operation of the vehicle on the highway; and

- there is a written manufacturer's statement or recommendation (which can include the owner's manual for the vehicle) that the vehicle should not be operated on the highway or should have limited operation on the highway.
- ensure modifications are not made or allowed to the vehicle's emissions control systems, hardware, software calibrations, or hybrid system (not applicable to converted EVs purchased from Upcycle Green Technology in PEI).

To receive a vehicle incentive the vehicle must remain plated, registered and insured in Prince Edward Island in the applicant's name for at least 12 months from date of sale. If before the 12 months is up, the applicant does not abide by all of the conditions listed, the applicant will be required to pay back a prorated amount of the incentive payable to the Minister of Finance

The UEV Incentive Program will be administered and implemented through a partnership between the Department of Environment, Energy and Climate Action and the Department of Transportation and Infrastructure. \*Nothing in the Terms and Conditions changes or supersedes any of the existing requirements of a Dealer's Trade License under the Highway Traffic Act and the associated Dealer's Trade License Regulations\*

As of March 25, 2025, Tesla will no longer be eligible for this rebate.

**As of June 2, 2025, the total incentive for BEVs is \$4000. For PHEVs the incentive is \$2000.** The program will no longer provide any additional funding for a charger, as it is included in the full rebate amount.
