AMBULANCE SERVICES ACT
GENERAL REGULATIONS
AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated July 29, 2025.)

Pursuant to section 23 of the *Ambulance Services Act* R.S.P.E.I. 1988, Cap. A-10.01, Council made the following regulations:

1. **Subsection 4(1) of the *Ambulance Services Act* General Regulations (EC530/13) is amended by the revocation of clauses (a) to (c) and the substitution of the following:**
 - (a) a vehicle-mounted two-way radio;
 - (b) two handheld two-way radios;
 - (c) two battery-operated flashlights;
 - (d) a dry chemical fire extinguisher;
 - (e) two high-visibility safety vests; and
 - (f) two emergency services or rescue helmets.
2. **Section 5 under the heading CLASS 1 AMBULANCE in Schedule A to the regulations is amended**
 - (a) **by the revocation of clause (b) and the substitution of the following:**
 - (b) at least two attendant seats with headrests, including
 - (i) one seat positioned by the head of the stretcher, facing toward the rear of the vehicle, and
 - (ii) one seat positioned beside the stretcher;
 - (b) **by the addition of the following after clause (d):**

- (d.1) an exhaust fan or air filtration device capable of evacuating or filtering any contaminated air from the patient compartment;
- 3. **Section 8 under the heading CLASS 1 AMBULANCE in Schedule A to the regulations is amended**
 - (a) **in clause (c), by the deletion of the words “and when” and the substitution of the word “or”;**
 - (b) **by the revocation of clause (e) and the substitution of the following:**
 - (c) rotating or strobe lights, mounted on or about the roof of the vehicle, that
 - (i) contain at least two of the colours red, white and blue,
 - (ii) are visible within a 150-meter radius of the vehicle, and
 - (iii) remain visible when the rear doors of the vehicle are open;
 - (d) **in clause (f), by the addition of the words “or blue” after the word “red”; and**
 - (e) **by the revocation of clause (h) and the substitution of the following:**
 - (f) a clear ditch light, mounted on the vehicle, capable of illuminating a work site or house number within 15 metres of the vehicle.
- 4. **Clause 8(c) under the heading CLASS 2 AMBULANCE in Schedule A to the regulations is amended by the deletion of the words “and when the transmission is in reverse gear”.**
- 5. **Schedule B to the regulations is revoked and Schedule B as set out in the Schedule to these regulations is substituted.**
- 6. **These regulations come into force on August 9, 2025.**

EXPLANATORY NOTES

SECTION 1 amends subsection 4(1) of the regulations to update the vehicle equipment required to be carried in an ambulance.

SECTION 2 amends section 5 under the heading CLASS 1 AMBULANCE in Schedule A to the regulations to update some of the design requirements for a class 1 ambulance.

SECTION 3 amends section 8 under the heading CLASS 1 AMBULANCE in Schedule A to the regulations to update the lighting requirements for a class 1 ambulance.

SECTION 4 amends section 8 under the heading CLASS 2 AMBULANCE in Schedule A to the regulations to update a lighting requirement for a class 2 ambulance.

SECTION 5 revokes Schedule B to the regulations and substitutes a new Schedule B, which is set out in the Schedule to these regulations.

SECTION 6 provides for the commencement of these regulations.
