Under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap N-3, the Dairy Farmers of Prince Edward Island Regulations thereunder, Dairy Farmers of Prince Edward Island makes the following Order:

CLASS 1 MILK PRODUCT PRICE DETERMINATION ORDER

- Application 1. This Order provides for the establishment of minimum wholesale prices for Class 1 milk products in Prince Edward Island.
- Classifications 2. The milk classifications that apply in this Order are those established by the current Dairy Farmers of Prince Edward Island Milk Classification Order.
- Definitions 3. In this Order:
 - (a) “distributor” means a person engaged in selling or distributing fluid milk products directly or indirectly to consumers, and for better certainty includes a processor, but does not include a storekeeper;
 - (b) “processor” means a person engaged in the processing of Class 1 milk or a Class 1 milk product; and
 - (c) “wholesale” means the price charged by a processor or a distributor to an institution or a retail outlet but does not include the price which consumers pay to a retail outlet.
- Sales prices 4. No processor or distributor shall offer for sale or sell a Class 1 milk product at a price less than the price established in section 6.
- Purchase prices 5. No distributor shall offer to purchase or purchase a Class 1 milk product at a price less than the minimum price established in section 6.
- Minimum wholesale prices 6. The minimum wholesale Class 1 milk product prices shall be:

ROADS ACT

**HIGHWAY ACCESS REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated January 13, 2026.)

Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

1. **Schedule A-3, Infilling Areas, to the *Roads Act* Highway Access Regulations (EC580/95) is amended in clause 1(4)(a) by the deletion of the words “intersection of RN 60206” and the substitution of the words “intersection of RN 60156”.**
2. **These regulations come into force on January 24, 2026.**

EXPLANATORY NOTES

SECTION 1 amends Schedule A-3, Infilling Areas, to the *Roads Act* Highway Access Regulations (EC580/95) to reclassify the specified segment of highway in the Town of Three Rivers from arterial to arterial infill to permit access to the highway for mixed use and highway commercial use along that portion of Route 4.

SECTION 2 provides for the commencement of the regulations.

**COLLEGE OF NURSING AND MIDWIFERY
REGULATIONS**

(Approved by His Honour the Lieutenant Governor in Council dated January 20, 2026.)

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

1. College of Nursing and Midwifery

(1) The College of Licensed Practical Nurses of Prince Edward Island, a body corporate continued under the Licensed Practical Nurse Regulations (EC150/18), and the College of Registered Nurses and Midwives of Prince Edward Island, a body corporate continued under the Registered Nurses and Registered Psychiatric Nurses Regulations (EC551/23), are hereby together continued as the Prince Edward Island College of Nursing and Midwifery, a body corporate.

Regulated health professions

(2) The Prince Edward Island College of Nursing and Midwifery is the college for the following regulated health professions:

- (a) midwifery;
- (b) nursing;
- (c) practical nursing;
- (d) psychiatric nursing.

2. Transitional, definitions

(1) In this section,

- (a) “**amalgamated college**” means the Prince Edward Island College of Nursing and Midwifery;
- (b) “**amalgamating college**” means the College of Licensed Practical Nurses of Prince Edward Island or the College of Registered Nurses and Midwives of Prince Edward Island.

Transitional, property and obligations

(2) On amalgamation under subsection 1(1),

- (a) the property of each amalgamating college continues to be the property of the amalgamated college;

- (b) the amalgamated college continues to be liable for the obligations of each amalgamating college;
- (c) an existing cause of action, claim or liability to prosecution is unaffected;
- (d) a civil, criminal or administrative action or proceeding pending by or against an amalgamating college may be continued to be prosecuted by or against the amalgamated college; and
- (e) a conviction against, or ruling, order or judgment in favour of or against, an amalgamating college may be enforced by or against the amalgamated college.

Transitional, council

(3) The members of each council of the amalgamating colleges holding office immediately before these regulations come into force are continued as the members of the first council of the amalgamated college until the expiry of the members' respective terms, unless they sooner cease to hold office.

Transitional, appointments

(4) A person appointed by the council of an amalgamating college as an investigator, or a member of an investigation committee or discipline committee, with an effective appointment immediately before these regulations come into force is considered to have been appointed by the council of the amalgamated college.

Transitional, members

(5) The persons who are members of an amalgamating college immediately before these regulations come into force continue as members of the amalgamated college.

Transitional, permit

(6) A permit issued by the registrar or council of an amalgamating college that is valid immediately before these regulations come into force is considered to have been issued by the council of the amalgamated college.

3. Commencement

These regulations come into force on April 1, 2026.

**LICENSED PRACTICAL NURSE REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated January 20, 2026.)

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

1. **The title of the *Regulated Health Professions Act* Licensed Practical Nurse Regulations (EC150/18) is amended by the deletion of the word “Nurse” and the substitution of the word “Nurses”.**
2. **Clause 1(b) of the regulations is revoked and the following substituted:**
 - (b) “College” means the Prince Edward Island College of Nursing and Midwifery;
3. **Section 3 of the regulations is revoked.**
4. **These regulations come into force on April 1, 2026.**
