#### Notice of Amendments to the Regulations to the Legal Profession Act

Amendments to the Regulations of the *Legal Profession Act* were approved at the Law Society's Mid-Winter Meeting in February 2024 and published in the Royal Gazette on April 13, 2024, resulting from the proclamation of Bill 22, an *Act to Amend the Legal Profession Act*. The Law Society at its Annual General Meeting on June 21, 2025, approved the following amendments to the Regulations.

The existing subsections to the Regulations are amended as follows (additions are <u>underlined</u> and deletions have strikethroughs):

#### Current Page 2 – insert at Interpretive area, before 1.

Pursuant to Section 6(2)(a) of the *Legal Profession Act*, S.P.E.I. 1992, Cap. 39, which empowers Council to make procedures, guidelines, and policies for the better administration of the Society, the Society and Council are hereby authorized to adopt and implement interpretive policies to guide the assessment and decision-making processes under these Regulations. Such interpretive policies are intended to clarify, supplement, and enhance the application of the Regulations and shall be consistent with the *Legal Profession Act*. Such policies shall be advisory and shall not limit the discretionary authority of the Council or the Secretary-Treasurer in determining whether an applicant is fit for and possesses the requisite qualifications and good character for admission.

#### **Current page 3 - Section 7(1)**

- 7 (1) The Secretary-Treasurer or, in the Secretary Treasurer's absence or temporary disability, such other member as the Council may appoint for that purpose shall: (a) attend all meetings of the Society and of the Council; (b) keep minutes of the proceedings of the meetings of the Society and of the Council; (c) conduct all necessary correspondence of the Society; (d) keep all records and documents of the Society and of the Council; (e) receive all monies payable to the Society and hold the same subject to the order of the Council; (f) perform all other services incidental to the office or which may be assigned to the Secretary-Treasurer by the Regulations of the Society.
  - (2) The Secretary-Treasurer may, at their discretion, designate another individual, including but not limited to a member of Council or staff, to assist with or assume any of the above duties, either on a temporary or ongoing basis, subject to any limitations or conditions set out in the designation.
  - (3) In the absence or temporary disability of the Secretary-Treasurer, the Council may appoint another member as Acting Secretary-Treasurer to perform any or all of the functions of the Secretary-Treasurer, including those required under the Act.

(4) The Secretary-Treasurer shall keep proper books of account and record therein all fees, levies, assessments and other financial transactions between the Society and its members whereby the state of the member's account at any time can be readily ascertained.

### **Current page 6 - Section 11(f)**

11 (f) present such further information and evidence as the <u>Secretary-Treasurer or</u> Council may require.

### **Current page 6 - Section 15(2)**

15(2) After enrolment as an articled clerk and before admission as a member, an articled clerk shall serve under articles of clerkship with one or more principals for a period full term of articles of clerkship of twelve months, unless abridged by the Secretary-Treasurer or by Council, where the Secretary-Treasurer in their discretion refers it to Council, for a person serving articles of clerkship pursuant to the requirements of subsection 18(1), which shall include the period of time required for the bar admission course. The term of service under the articles of clerkship may be extended to cover the time, if any, between the completion of twelve months of articles and completion of the bar admission course.

### Current page 7 - Section 15(10)

15(10) A person who has applied under Section 11 may be approved by the Secretary-Treasurer or by the Council where the Secretary-Treasurer in their discretion refers it to Council for admission to practice as a barrister, solicitor and attorney if the applicant for admission produces evidence to the satisfaction of the Secretary-Treasurer or the Council, as applicable, that the applicant has paid all fees herein and has satisfied every other requirement of the Secretary-Treasurer, the Council, and these Regulations, and applicable policies, and the applicant, in the case of an articled clerk who holds a law degree from any Canadian common law school approved by the Federation of Law Societies of Canada, has completed a course of studies approved by the Council, has complied with this section and produces a certificate of good moral character from the individuals with whom the applicant has articled.

#### **Current page 11 - Section 17(7)**

17(7) Upon the applicant complying with subsections (2), (3), (4) and (6), the *Secretary-Treasurer or* Council shall determine whether the applicant is a fit and proper person fit for and possesses the requisite qualifications and good character to be admitted to the bar and shall grant or refuse admission accordingly.

#### Current page 12 - Section 17.1(2)

17.1(2)Upon the applicant complying with subsection (1), the <u>Secretary-Treasurer or Council</u> shall determine whether the applicant is a <u>fit and proper person-fit for and possesses the requisite qualifications and good character</u> to be admitted to the bar as a Canadian Legal Advisor and shall grant or refuse such admission accordingly.

### Current page 14 - Section 18(1)(c)

- 18(1) (c) subsequent to obtaining a certificate of qualification,
  - (i) the applicant successfully completes a six month-full term of articles of clerkship, if the applicant has been engaged full time in the actual practice of law for at least three years in the five years in the five year period immediately preceding the date of his or her application of twelve months; or
    - (ii) successfully completes a term of articles of clerkship of twelve months;"
  - (ii) the applicant is eligible, applies for, is granted, and completes an abridged articling term.
    - 1. The applicant is eligible for an abridged articling term if the applicant has been engaged full time in the actual practice of law for at least three years within the five years immediately preceding their application. In such cases, the applicant may apply to the Secretary Treasurer for an exemption from the requirement to complete a portion of the full term of articles of clerkship of twelve months by submitting the required application and furnishing all documentation specified in the applicable policy. Approval of the abridgement application shall be based on policy.
    - 2. An application under subsection 18(c)(ii) may be approved, approved with conditions, or denied by the Secretary-Treasurer or by Council where the Secretary-Treasurer, in their discretion, refers it to Council, as set out in policy.

#### **Current page 14 - Section 18(3)**

18(3) Upon the applicant complying with subsections 18(1) and 18(2), the <u>Secretary-Treasurer or Council shall determine whether the applicant is a fit and proper person-fit for and possesses the requisite qualifications and good character to be admitted to the bar and shall grant or refuse admission accordingly.</u>

#### Current page 14 - Section 19(1)

19(1) Every applicant for admission to practice to the bar as a member shall file with the Secretary-Treasurer the documents required by the Regulations and policy.

### Current page 15 - Section 19(2)(b)

19(2) (b) where no service under articles was required, by a member of Council in good standing who is and has been in the actual practice within the Province for the five (5) years preceding the call to the bar.

#### Current page 27 - Section 34

34. The applicant may be approved to act as a foreign legal consultant if the applicant satisfies the Secretary Treasurer or the Council that the applicant,

#### Current page 27 - Section 34(b)

34. (b) is a person of good moral character and a fit and proper person who is fit for and possesses the requisite qualifications and good character to practice as a foreign legal consultant in the Province;

### **Current page 30 - Section 47(3)**

- 47(3) If:
  - (a) the application is made more than one three years after the end of the applicant's term in a judicial office, or
  - (b) the facts disclosed in the application or otherwise known to the Society raise public interest issues which, in the opinion of the Secretary-Treasurer, require consideration by the Council, the Secretary-Treasurer shall forward the application to the Council.

#### Current page 30 - Section 47(4)

47(4) The <u>Secretary-Treasurer or the</u> Council may require the applicant to file such additional information as it considers appropriate.

#### Current page 30 - Section 47(5)

47(5) Where the <u>Secretary-Treasurer or the</u> Council is satisfied that it is consistent with the public interest, it may approve the reinstatement to membership upon such terms and conditions as it deems fit and necessary.

#### Current page 32 - Section 48(7)

48(7) When the <u>Secretary-Treasurer or the</u> Council is satisfied that it is consistent with the public interest it may approve the change in category of membership upon such terms and conditions as it deems fit and necessary.

#### Current page 33 - Section 49(5)

- 49(5) Following consideration of the application, the <u>Secretary-Treasurer or the</u> Council may, when it is in the public interest to do so:
  - (a) approve the application with or without conditions,
  - (b) approve the application, subject to the applicant
    - (i) satisfactorily completing a period of service with a practicing lawyer, in accordance with an education plan approved by the <u>Secretary-Treasurer or the</u> Council
    - (ii) successfully completing all or a portion of the Bar Admission Course
    - (iii) satisfying the <u>Secretary-Treasurer or the</u> Council of the applicant's fitness for resumption or practice, or
    - (iv) completing such other requirements as may be required by the <u>Secretary-Treasurer</u> or the Council.

#### Current page 34 - Section 50(5)

50(5) When the <u>Secretary-Treasurer or the</u> Council is satisfied that it is consistent with the public interest, it may approve the change in category of membership upon such terms and conditions as it deems fit and necessary.

#### Current page 41 - Section 56

56. (1) The conduct of any member or articled clerk may be investigated, upon the receipt by the Secretary-Treasurer, from a member of a Committee (acting either on the member's own volition or pursuant to a motion of the Committee), a member of the Society, or a member of the public, of a written complaint alleging unprofessional

- conduct on the part of a member or, in respect of an articled clerk, conduct unbecoming an articled clerk.
- (1.1) Member's conduct which comes to the Secretary-Treasurer's attention from sources such as media articles or judge's decisions may be handled in the in the following ways:
  - 1. The Secretary-Treasurer may write to the member involved to request an explanation and the background regarding the matter.
  - 2. If, upon receipt of the member's response, the Secretary-Treasurer is concerned about the member's conduct, the Secretary-Treasurer may forward the materials gathered to one of the Discipline Committees.
  - 3. The Committee, if warranted, may commence an investigation pursuant to Regulation 55(1) and/or 59 (11) which gives it the authority to "investigate on its own initiative".
  - 4. If in the opinion of the Secretary-Treasurer the conduct is of a serious nature, the matter may instead be referred to Council who may deal with it pursuant to its discipline authority or may refer the matter to a Discipline Committee for an investigation.
  - (2) The representative of the Society's insurer may disclose to a Committee any information not protected by solicitor-client privilege which appears to the representative to disclose unprofessional conduct.

#### Current page 41 - Section 57

- 57. (1.2) Upon receipt of a written complaint pursuant to section 56, if the Secretary-Treasurer does not dismiss the complaint pursuant to subsection 57(1), the Secretary-Treasurer shall request a written response from the member or articled clerk complained of, and shall forward such response to the complainant.
  - (1.3) When the Secretary-Treasurer sends a matter to a committee where there has been no written complaint or referral from Council, the Committee will first determine whether it wishes to invoke its jurisdiction to investigate "on its own initiative" pursuant to the authority contained in subsections 55(1) and/or 59(11).
  - (2) The Secretary-Treasurer shall obtain such further particulars and make such inquiries as the case requires, which may include receiving verification of the facts alleged by the complainant by statutory declaration.

63(2) (a) If a member or an articled clerk has been charged with a criminal offence, the member or articled clerk shall report the charge forthwith to the Secretary-Treasurer. A charge

- may result in the Secretary-Treasurer imposing restrictions on the practice of the member or the articled clerk if, in the judgement of the Secretary-Treasurer, there is a risk to the public.
- (b) If a member or an articled clerk has been found guilty of a criminal offence, a Committee may, by such notice as it prescribes, require the member or articled clerk to attend a show cause hearing to establish why the member or articled clerk should not be subjected to any disciplinary action. A person so found guilty shall report the finding of guilt forthwith to the Secretary-Treasurer.
