



7 Record History

On the left-hand side of your MyHealthPEI dashboard, you will see an option for **Record History**. **Record History** is a tool that allows you to see activity that has taken place in your record. This includes any updates made to your information (for example: the addition of new self-entry data or personal notes, or provincial information such as lab results and immunizations) along with a record of those few authorized individuals who have viewed your test results or reports (please see the [Security and Privacy FAQs](#) for more details).

To view this information, click on the **Record History** button.



On the **Record History** page, you can choose from several options to see more details about the changes or views you're interested in, including:

1. Changes Based on When They Were Made
2. Changes Made By a Specific Person or Account
3. Changes Made By Your Providers
4. Changes Made Using a Specific App
5. Other Activity

7.1 Changes Based on When They Were Made

The **Changes Based on When They Were Made** view will show you changes made to your MyHealthPEI records, including: the addition, editing or deletion of self-entry information (for example, family history, allergies, medical conditions); the addition of or updates to personal notes; the uploading of lab results, diagnostic imaging reports, and immunizations into MyHealthPEI from your provincial electronic health record; and, information on any community-based providers who have accessed your record and why.

You can choose to view all changes within the last 30 days, 6 months, or for a customizable period of time, available in the “**A Different Period of Time**” drop-down menu.

The below screenshot shows a few different types of information you may see when you click on **Record History**, including: the creation of a personal note / comment; the creation, updating, and deletion of a medical condition; and the addition of a lab result:

You can also see if anyone has viewed your health record within the selected period of time.

As a reminder, there are a limited number of authorized individuals who will have access to the information within MyHealthPEI, such as technical support for maintaining the system. Pharmacists will also have access to your lab results and immunizations to help them while providing you care. In the future, other health care provider groups may have access to diagnostic imaging reports like x-rays, but only when providing you health care.

If a provider was to access your record for the purpose of providing you care, you would see the name of the provider, their license number, and the reason for accessing the record, as pictured below:

7.2 Changes Made By a Specific Person or Account

The **Changes Made By a Specific Person or Account** view will show changes that you have made to your MyHealthPEI records or instances where information was pulled from any linked smart device, including the

addition, editing or deletion of self-entry information (for example, family history, allergies, medical conditions, sleep, exercise). You will also see information uploaded into MyHealthPEI from your provincial electronic health record, including lab results, diagnostic imaging, and immunizations.

7.3 Changes Made By Your Provider

The **Changes Made By Your Provider** view displays a list of all instances where a healthcare provider accessed your health information. This may be pharmacists viewing your immunization history or lab results for the purpose of providing you treatment. You may also see instances where the MyHealthPEI support team accessed your records to provide technical support.

7.4 Changes Made Using a Specific App

The **Changes Made Using a Specific App** view displays updates or additions to your record from three sources: (1) information you enter yourself or upload via an authorized smart device, (2) new data received from your provincial electronic health record, such as lab results, diagnostic imaging reports, and immunizations, and 3) record access through the MyHealthPEI Provider Portal (ie. pharmacists accessing your record for a specific reason while providing you care).

When you see a record in your history assigned to “System and Profile Repository”, this refers to information that was uploaded by an authorized device, such as a smart watch you linked to your account, or results that were pulled into MyHealthPEI from your provincial electronic health record.

The **Other Activity** view offers two options for drilling down into both access-related changes as well as record views. These include: 1) Views of Record in the Last 30 Days, and 2) Access-Related Changes to your Record:

The **Views of Record in the Last 30 Days** option will show you any instances that your record has been accessed. This could be by yourself or an authorized health care provider, such as a pharmacist referencing your immunization history or lab results for the purpose of providing you care.

The **Access-Related Changes to your Record** option will show you which authorized users accessed your record for the purpose of viewing or uploading information into your MyHealthPEI account.
