Notice of Amendments to the Regulations to the Legal Profession Act

The Law Society at its Annual General Meeting on June 21, 2025, approved amendments to the Regulations of the *Legal Profession Act*. On August 19, 2025, the Law Society of PEI submitted these amendments which were published on August 23, 2025. We are submitting the following amendments to correct administrative errors found in the publication of August 23, 2025.

The existing subsections to the Regulations are amended as follows (additions are underlined and deletions have strikethroughs):

Current page 12 - Section 17.1(2)

17.1(2) Upon the applicant complying with subsection (1), the ~~Secretary-Treasurer or Secretary-Treasurer~~ or Council shall determine whether the applicant is fit for and possesses the requisite qualifications and good character to be admitted to the bar as a Canadian Legal Advisor and shall grant or refuse such admission accordingly.

Current page 14 - Section 18(1)(c)

18(1) (c) (ii) the applicant is eligible, applies for, is granted, and completes an abridged articling term.

1. The applicant is eligible for an abridged articling term if the applicant has been engaged full time in the actual practice of law for at least three years within the five years immediately preceding their application. In such cases, the applicant may apply to the Secretary-Treasurer for an exemption from the requirement to complete a portion of the full term of articles of clerkship of twelve months by submitting the required application and furnishing all documentation specified in the applicable policy.
