EC2026-379

EMPLOYMENT STANDARDS ACT
MINIMUM WAGE ORDER

(Approved by His Honour the Lieutenant Governor in Council dated March 31, 2026.)

Pursuant to section 5 of the *Employment Standards Act* R.S.P.E.I. 1988, Cap. E-6.2, Council approved the following Minimum Wage Order made by the Employment Standards Board:

1. Minimum Wage

The minimum wage for all employees to whom section 5 of the *Employment Standards Act* R.S.P.E.I. 1988, Cap. E-6.2, applies shall be

- (a) \$17.30 per hour, effective on and after October 1, 2026; and
- (b) \$17.60 per hour, effective on and after April 1, 2027.

2. Board and lodging

- (1) The maximum amount an employer may deduct from the wages of an employee to whom section 5 of the *Employment Standards Act* applies for furnishing board or lodging to the employee is as follows:

- (a) \$61.60 per week, for board and lodging;
- (b) \$49.50 per week, for board only;
- (c) \$27.50 per week, for lodging only;
- (d) \$4.25 per meal, for single meals.

Meal not received

- (2) An employer shall not deduct an amount from the wages of an employee pursuant to clause (1)(d) for a meal the employee did not receive.

3. Revocation

The *Employment Standards Act* Minimum Wage Order (EC326/25) is revoked.

4. Commencement

This Order comes into force on October 1, 2026.

EC2026-420

PUBLIC HEALTH ACT
IMMUNIZATION REGULATIONS
AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated March 31, 2026.)

Pursuant to section 72 of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30.1, Council made the following regulations:

1. Clauses 1(b.1) to (e) of the Immunization Regulations (EC529/14) are revoked and the following substituted:

- (c) “**immunize**” means to administer an immunizing agent;
- (d) “**immunizing agent**” means a vaccine, an immune globulin, or preventative monoclonal antibodies;
- (e) “**member of a regulated health profession**” means a member of a regulated health profession under the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1.

2. Subsection 2(1) of the regulations is amended

- (a) **in the words before clause (a), by the deletion of the words “administers a vaccine to” and the substitution of the word “immunizes”; and**
- (b) **by the revocation of clauses (a) to (h) and the substitution of the following:**
 - (a) the patient’s name, date of birth, sex, address and provincial health number;
 - (b) the name or drug identification number of the immunizing agent;
 - (c) the date of immunization;
 - (d) the name and location of the clinic or other place where the patient was immunized.

3. (1) Subsection 3(1) of the regulations is revoked and the following substituted:

3. Immunization records

(1) A member of a regulated health profession who immunizes a patient shall record the following information:

- (a) the patient's name, date of birth, sex, address and provincial health number;
- (b) the name, dose, manufacturer and lot number of the immunizing agent;
- (c) the immunization route and site on the patient's body;
- (d) the date of immunization;
- (e) the member's name.

(2) **Subsection 3(2) of the regulations is amended by the deletion of the word "vaccination" and the substitution of the word "immunization".**

4. Section 4 of the regulations is amended by the deletion of the words "administering a vaccine" and the substitution of the word "immunizing".

5. Clause 5(2)(c) of the regulations is amended by the deletion of the word "vaccines" and the substitution of the words "immunizing agents".

6. (1) Clauses 6(1)(a) to (e) of the regulations are revoked and the following substituted:

- (a) any of the following members of a regulated health profession:
 - (i) a licensed practical nurse,
 - (ii) a medical practitioner,
 - (iii) a midwife,
 - (iv) a pharmacist or pharmacy technician,
 - (v) a registered nurse or nurse practitioner;
- (b) a person employed to provide administrative support services to a medical practitioner, nurse practitioner or public health nurse.

(2) **Subsection 6(2) of the regulations is revoked and the following substituted:**

Access granted

- (2) On receipt of an application in accordance with subsection (1), the Chief Public Health Officer may grant the person access to the immunization registry if
- (a) in the case of an applicant referred to in clause (1)(a), the person is
 - (i) engaged or employed in providing health care in the person's professional capacity, and
 - (ii) in good standing with the college governing the regulated health profession of which the person is a member;
 - (b) in the case of an applicant referred to in clause (1)(b), the person requires access to the immunization registry for the purposes of the person's employment.

- (3) **Subsection 6(4) of the regulations is revoked and the following substituted:**

Requirements no longer met

- (4) An authorized user granted access to the immunization registry under this section shall cease to have access if the authorized user ceases to meet the applicable requirements under clause (2)(a) or (b).

7. **These regulations come into force on April 11, 2026.**

EXPLANATORY NOTES

SECTION 1 amends section 1 of the Immunization Regulations to remove unnecessary definitions of "midwife", pharmacist", "pharmacy technician" and "vaccine" and add definitions of "immunize" and "immunizing agent". It also renumbers the definition of "member of a regulated health profession".

SECTION 2 amends subsection 2(1) of the regulations to refer to an immunizing agent instead of a vaccine, and to refer to immunizing a person instead of administering a vaccine to a person. This reflects that immunization is not limited to vaccines.

SECTION 3 amends section 3 of the regulations to refer to an immunizing agent instead of a vaccine, and to refer to immunizing a person instead of administering a vaccine to a person.

SECTION 4 amends section 4 of the regulations to refer to immunizing a person instead of administering a vaccine to a person.

SECTION 5 amends clause 5(2)(c) of the regulations to refer to an immunizing agent instead of a vaccine.

SECTION 6 amends subsections 6(1), (2) and (4) of the regulations to replace gendered language with gender-neutral language and improve the wording.

SECTION 7 provides for the commencement of these regulations.

EC2026-421

REGULATED HEALTH PROFESSIONS ACT OCCUPATIONAL THERAPISTS REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated March 31, 2026.)

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

1. **The *Regulated Health Professions Act Occupational Therapists Regulations* (EC34/18) are amended by the addition of the following after section 12:**

PART 3.1 – RESERVED ACTIVITIES

12.1 Application for special authorization

- (1) An occupational therapist may apply to the registrar, in the form approved by the Council, for special authorization to perform the reserved activity of applying electrical energy in providing treatment.

Eligibility

- (2) An applicant is eligible for special authorization to perform the reserved activity referred to in subsection (1) if the applicant has successfully completed a program in functional electrical stimulation approved by the Council.

Granting of special authorization

- (3) On receipt and review of an application made in accordance with subsection (1), the registrar may, if the registrar is satisfied the applicant has completed the required training program in accordance with subsection (2),
- (a) grant the applicant special authorization to perform the reserved activity; and
 - (b) note the special authorization in the register in relation to the occupational therapist and on the occupational therapist's certificate of registration.

Referral to the Council

- (4) Where the registrar is not satisfied that the applicant has completed the required training program in accordance with subsection (2), the registrar shall refer the application to the Council.

Review by the Council

- (5) On receipt of an application referred by the registrar, the Council shall review the application and may
- (a) direct the registrar to
 - (i) grant the applicant special authorization to perform the reserved activity, and
 - (ii) note the special authorization in the register in relation to the occupational therapist and on the occupational therapist's certificate of registration; and
 - (b) impose any terms and conditions on the special authorization that the Council considers appropriate.

Notice of refusal

- (6) On refusing to grant special authorization to perform the reserved activity, the Council shall serve on the applicant written notice of the refusal, including reasons, and the applicant's right to appeal the refusal.

Appeal

- (7) An occupational therapist who is aggrieved by a refusal of the Council to grant a special authorization to perform the reserved activity may appeal the refusal to the Supreme Court within 30 days after being served with notice of the refusal.

Powers of court

- (8) On hearing the appeal, the court may
- (a) confirm the refusal;
 - (b) refer the matter, or any issue, back to the Council for further consideration; or
 - (c) provide any direction that it considers appropriate.

Costs

- (9) The court may make any order as to the costs of an appeal that it considers appropriate.

Suspension, cancellation, expiration, renewal

- (10) A special authorization granted under this section is suspended or cancelled, or expires, on the suspension, cancellation or expiration of the occupational therapist's registration, as the case may be, and may be renewed on renewal of the occupational therapist's registration.

5. **These regulations come into force on April 11, 2026.**

EXPLANATORY NOTES

SECTION 1 adds a new heading and section 12.1 to the Occupational Therapists Regulations providing for an occupational therapist to obtain a special authorization to perform the reserved activity of applying electrical energy in providing treatment.

SECTION 2 provides for the commencement of these regulations.
