## ENVIRONMENTAL SCHOOL CHALLENGE AWARD

Schools are eligible for the Environmental School Challenge. This award includes a **\$3,000 prize** for schools that take on an environmental challenge or develop their own environmental initiative.

## Selection Process and Criteria

Nominations will be assessed by a selection committee composed of members of the Minister's Environmental Advisory Council.

To be eligible for an award, an individual or organization must have been instrumental in:

- identifying, reducing, solving or avoiding an environmental problem;
- demonstrating consistently responsible environmental management practices; and/or
- promoting public awareness, understanding and active concern for the enhancement and protection of the environment.

In addition, the review committee will also consider the nominees':

- long-term service and commitment;
- voluntary contributions; and
- innovative approach.

Announcement of award recipients will be made by the Minister of Environment, Water and Climate Change Spring 2021. Award recipients will be contacted prior to the announcement.
