NOTES

- (A) STATISTICS ON FISH PURCHASES AND SALES MUST BE PROVIDED TO THE PRINCE EDWARD ISLAND DEPARTMENT OF FISHERIES REGISTRAR OF LICENSING IN ACCORDANCE WITH THE REPORTING PROVISIONS OF THE *FISHERIES ACT REGULATIONS 8(3) (b)*.
- (B) HOLDING, HANDLING AND THE TRANSPORTATION OF FISH MUST BE IN ACCORDANCE WITH THE REGULATIONS MADE UNDER THE *PEI FISH INSPECTION ACT*, SCHEDULES "E" AND "G".
- (C) PEDDLER LICENSES ARE ISSUED ANNUALLY AT A FEE OF \$25.00 PER VEHICLE.
- (D) LICENSE FEES CAN BE PAID BY CASH, CHEQUE OR MONEY ORDER [SECTION 9(3) AND SCHEDULE 6 OF THE *PEI FISHERIES ACT REGULATIONS*]. **IF APPLYING ONLINE, PAY BY CREDIT CARD.**
- (E) ALL INFORMATION MUST BE PROVIDED BEFORE THE ISSUANCE OF A LICENSE WILL BE CONSIDERED.
