

SPECIAL EVENT SIGNAGE APPLICATION

The Department of Transportation and Infrastructure recognizes the importance of festivals and special events and their impact on the Island's tourism industry. This is due to the numerous, unique, and quality festivals and events held each year across the Province and the tremendous amount of time and effort put into organizing these events.

An integral part of the success of your festival/event is directing traffic to your event through the use of signs. As part of your planning process, it is important that you consider proper procedure in relation to special event signage. The *Highway Signage Act* recognizes the Island's landscape as a valuable resource for the tourism industry and thus establishes restrictive measures on the use of special event signage.

The *Act* regulates the use of special event signs used to promote a festival or special event. Special event signs are erected prior to an even and these signs are removed immediately after the event. The policy for size of special events is 61 cm x 61 cm (2' x 2').

Festivals and events require special permits to allow for special event signage. We ask for your support in this matter and request you submit your application to Transportation and Infrastructure , describing the type of signage, the locations, and the duration the signs will be in place. **Please note that signs cannot be attached to utility poles or be located in any way that endangers the safety of the traveling public.**
