**COMPANIES ACT**  
**Chapter C-14**  
**FEES REGULATIONS**

Pursuant to section 81 of the *Companies Act* R.S.P.E.I. 1988, Cap. C-14, Council made the following regulations:

**1. Fees**

The following fees are prescribed:

(1)	On applications for Letters Patent incorporating a company with share capital (Part I companies)	\$250
(2)	On applications for Letters Patent incorporating a company without share capital (Part II companies)	\$125
(3)	On applications for Supplementary Letters Patent	\$250
(4)	On applications for a change of company name	\$250
(5)	On amalgamations by Letters Patent of two or more companies	\$250
(6)	On applications for revival of companies	\$250
(7)	On applications for continuance of companies	\$250
(8)	On applications for discontinuance of companies	\$250
(9)	On applications for surrender of charter	\$125
(10)	Name Searches	
	(a) for a level 1 search of corporate and business names in the Atlantic Provinces plus Federal corporations and trademarks, using the Newly Upgraded Automated Name Search System	\$40
	(b) for a level 2 search of corporate and business names throughout Canada plus trademarks, using the Newly Upgraded Automated Name Search System	\$50
(11)	For a certified copy of Letters Patent, Supplementary Letters Patent, Certificate of Name Change, Certificate of Dissolution, Certificate of Revival, Certificate of Continuance, Certificate of Discontinuance, or Certificate of Good Standing	\$30
