### PRINCE EDWARD ISLAND LANDS PROTECTION ACT Chapter L-5

#### **FORMS REGULATIONS**

Pursuant to clause 17(1)(c) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council made the following regulations:
