Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

**1. Schedule C-1, Local (Class 1) Highways, of the *Roads Act* Highway Access Regulations (EC580/95) is amended by the revocation of subsection (359) and the substitution of the following:**

(359) **Road Index 41070:** The paved portion of Road Index 41070, Sherry Road, commencing at the intersection of Route 119 in the settlement of Fernwood for a distance of 0.68 km.

**2. Schedule D, Seasonal Highways, of the regulations is amended by the revocation of subsection (625) and the substitution of the following:**

(625) **Road Index 41070:** Road Index 41070, Sherry Road, in the settlement of Fernwood commencing at a point 0.68 km from the intersection of Route 119, for a distance of 0.6 km.

**3. These regulations come into force on January 17, 2009.**

**EXPLANATORY NOTES**

**SECTIONS 1 and 2** amend the length and location of Class 1 Local and Seasonal Highway descriptions of Road Index 41070, the Sherry Road, which will allow for subdivision and development along the seasonal portion of this highway.

**SECTION 3** provides for the commencement of these regulations.

**EC2009-32****ROADS ACT  
HIGHWAY ACCESS REGULATIONS
