**PRINCE EDWARD ISLAND
LANDS PROTECTION ACT
PROPERTY NO. 728162, LOT 21, QUEENS COUNTY
IDENTIFICATION FOR NON-DEVELOPMENT USE
AMENDMENT**

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately one hundred and fifty-two decimal nine nine (152.99) acres of land, being Provincial Property No. 728162 located in Lot 21, Queens County, Prince Edward Island and currently owned by MacEwen Farms Ltd. of New London, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately four (4) acres, and determined that following subdivision, identification for non-development use shall continue to apply to the remaining land.

This Order-in-Council comes into force on 4 February 2009.
