**EC2010-233****PUBLIC HEALTH ACT  
NOTIFIABLE AND COMMUNICABLE DISEASES  
REGULATIONS  
AMENDMENT**

Pursuant to section 23 of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30, Council made the following regulations:

**1. Section 17 of the *Public Health Act* Notifiable and Communicable Diseases Regulation (EC330/85) is amended**

- (a) by addition of the following after paragraph (a)(ii)(C):  
(C.1) *Clostridium Difficile*,
- (b) in paragraph (a)(x)(G), by addition of the words “and non-B” after the words “*Haemophilus Influenzae B*”;
- (c) in subclause (a)(xvi), by the deletion of the word “and”;
- (d) in subclause (a)(xvii), by the deletion of the semicolon and the addition of the words “, and”; and
- (e) by the addition of the following after subclause (a)(xvii):  
(xviii) novel organisms;

**2. These regulations come into force on April 24, 2010.****EXPLANATORY NOTES**

**SECTION 1** adds *Clostridium Difficile*, non-B *Haemophilus Influenzae* infections, and novel organisms to the list of diseases that must be reported under the regulations.

**SECTION 2** provides for the commencement of these regulations.
