This Council in Committee, having under consideration the Estimates of Current Expenditure required to carry on the Public Service of the Province for the Fiscal Year ending March 31, 2011, and amounting in all to the sum of One Billion, Four Hundred and Seventy-Eight Million, Three Hundred and Seventy-Eight Thousand, Nine Hundred Dollars (\$1,478,378,900) together with a sum sufficient for similar expenditure, to carry on the Public Service of the Province from the expiration of the Fiscal Year ending March 31, 2011 up to and until the final passage of the Current Estimates for the Fiscal Year ending March 31, 2012, it was and is hereby recommended that the Current Estimates be approved by Her Honour, the Lieutenant Governor of the Province of Prince Edward Island, and be presented to the Legislative Assembly during the present session thereof.

CONFIRMATION ORDER**

Whereas, the Parliament of Canada enacted the *Economic Recovery Act (stimulus)*, Statutes of Canada, 2009, c. 31, (hereinafter referred to as the “Act”) which received Royal Assent on December 15, 2009.

And Whereas subsection 43(2) of the Act provides that sections 25 to 42 of the Act come into force in accordance with subsection 114(4) of the *Canada Pension Plan*, R.S.C., 1985, c. C-8, (hereinafter referred to as the “CPP”).

And Whereas when sections 25 to 42 of the Act come into force, they will alter the matters referred to in subsection 114(4) of the CPP.

And Whereas subsection 114(4) of the CPP provides that where any enactment of Parliament contains any provision that, among other things, alters the matters referred to in that subsection, it shall be deemed to be a term of that enactment, whether or not it is expressly stated in the enactment, that the provisions shall come into force only on a day to be fixed by order of the Governor in Council, which order may not be made and shall not in any case have any force or effect unless the lieutenant governor in council of each of at least two thirds of the included provinces, having in the aggregate not less than two thirds of the population of all of the included provinces, has signified the consent of the province to the enactment.

Therefore the Lieutenant Governor in Council of the Province of Prince Edward Island, on the recommendation of the Minister of Finance and Municipal Affairs, in accordance with subsection 114(4) of the CPP, is pleased to hereby signify the consent of the Province of Prince Edward Island to the enactment of sections 25 to 42 of the *Economic Recovery Act (stimulus)*, Statutes of Canada, 2009, c. 31.
