L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately twenty-six decimal seven three (26.73) acres of land, being Provincial Property No. 228197 located in Lot 31, Queens County, Prince Edward Island and currently owned by Oswald MacEachern of Clyde River, Prince Edward Island.

This amendment will enable subdivision of one lot of approximately one decimal one eight (1.18) acres for rural tourism use and two lots for residential single family dwelling use intended for children of the property owner, one lot of approximately one decimal six (1.6) acres and the other approximately one decimal six five (1.65) acres. Council noted that the property is located within the Cornwall Region Special Planning Area and that approval is subject to the subdivision meeting all requirements of the *Planning Act*, R.S.P.E.I. 1988, Cap.
