- (c) by the revocation of clause (d).

**(3) Subsection 50.3(8) of the regulations is amended**

- (a) in clause (b), by the addition of the word “and” after the semicolon;
- (b) in clause (c), by the deletion of the words “; and” and the substitution of a period; and
- (c) by the revocation of clause (d).

**2. These regulations come into force on April 11, 2015.**
