Pursuant to subsection 1.1(10) of the *Prince Edward Island Lands Protection Act* Exemption Regulations (EC368/88), Council amended the approval granted via Order-in-Council EC2007-300 dated May 22, 2007 (as amended by EC2013-302 dated April 30, 2013 and EC2015-116 dated March 3, 2015) to Linkletter Farms Ltd. and Link Agro Services Ltd. as an approved cooperative venture in respect of establishing and operating a potato services facility on land specified in the approval. This amendment permits an increase of two decimal nine one (2.91) acres to the land holding specified in the approval SUBJECT TO the additional land being consolidated with Provincial Property No. 65219, located at Miscouche, Lot 17, Prince County, being the land previously approved for establishment and operation of the said potato services facility.

Order-in-Council EC2007-300 is hereby amended by the deletion of the words “nineteen (19) acres” and the substitution of the words “twenty-one decimal nine one (21.91) acres”.

This Order-in-Council comes into force on April 14, 2015.
