EXECUTIVE COUNCIL ACT  
AND  
PUBLIC WORKS ACT  
PROVINCIALY OWNED LAND  
LEASE AGREEMENT WITH THE  
PRINCE EDWARD ISLAND SNOWMOBILE ASSOCIATION INC.

Pursuant to clause 10(d) of the *Executive Council Act* R.S.P.E.I. 1988, Cap. E-12 and subsection 13(7) of the *Public Works Act* R.S.P.E.I. 1988, Cap. P-34, Council authorized the Minister of Transportation, Infrastructure and Energy to enter into a lease agreement with the Prince Edward Island Snowmobile Association Inc. for the purpose of a recreational snowmobile trail, on approximately one thousand eight hundred and fifty-seven (1,857±) linear acres of land, located from Tignish, Lot #1, to Elmira, Lot #47, in Prince, Queens and Kings Counties, being the leased area to be renewed, and approximately fifty-five (55±) linear acres of land, located from Hermitage, Lot #48, to Iona, Lot #57, in Queens County, being newly developed trail.

The lease agreement is to be for a term of ten (10) years with a floating annual start date and a floating annual end date; to be suspended from April 1<sup>st</sup> to November 30<sup>th</sup> in each year during the term; and for the nominal fee of one dollar (\$1.00) plus associated costs. The lease agreement will also have a provision of exclusive use during periods of sufficient snow coverage.

L-5 Council granted permission to Great Enlightenment Buddhist Institute Society of Montague, Prince Edward Island to acquire a land holding of approximately one hundred and ninety-five decimal seven (195.7) acres of land at Heatherdale, Lot 59, Kings County, Province of Prince Edward Island, being acquired from Tachun Cho of Montague, Prince Edward Island PROVIDED THAT identification for non-development use pursuant to the Land Identification Regulations (EC606/95) made under the said Act shall apply to each of the three (3) separate subdivided lots comprising Provincial Property No. 253666 that has received planning approval and also to the remaining land of approximately one hundred and twenty-six decimal eight (126.8) acres.

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately ninety-nine decimal three five (99.35) acres of land, being Provincial Property No. 097634 located at Springfield, Lot 67, Queens County, Prince Edward Island and currently owned by Springdale Dairy Farms Inc. of Breadalbane, Prince Edward Island.

Council noted that this amendment will enable subdivision of one (1) lot of approximately two (2) acres for residential purposes, and determined that following subdivision, identification for non-development use shall continue to apply to the remaining land.

This Order-in-Council comes into force on November 15, 2016.
