EC2018-328**PLANNING ACT
SUBDIVISION AND DEVELOPMENT REGULATIONS
AMENDMENT**

Pursuant to sections 8 and 8.1 of the *Planning Act* R.S.P.E.I. 1988, Cap. P-8, Council made the following regulations:

1. Subsection 42(1) of the *Planning Act* Subdivision and Development Regulations (EC693/00) is amended

(a) in clause (d), by the deletion of the word “or” after the semicolon;

(b) in clause (e), by the deletion of the period and the substitution of the words “; or”; and

(c) by the addition of the following after clause (e):

(f) for institutional use on the property located at civic address 2661 Heatherdale Road, Route 316.

2. These regulations come into force on June 9, 2018.**EXPLANATORY NOTES**

SECTION 1 amends subsection 42(1) of the Subdivision and Development Regulations to add an exception for multiple buildings for institutional uses, in this case dormitories, located at 2661 Heatherdale Road, Route 316.

SECTION 2 provides for the commencement of the regulations.
