EDUCATION AUTHORITY REGULATIONS
AMENDMENT**

Pursuant to subsections 12(2) and 13(4) and section 107 of the *Education Act* R.S.P.E.I. 1988, Cap. E-.02, Council made the following regulations:

1. Subsection 27(2) of the *Education Act* Education Authority Regulations (EC524/16) is amended by the deletion of the words “September 15” and the substitution of the words “August 1”.

2. These regulations come into force on February 8, 2020.

EXPLANATORY NOTES

SECTION 1 amends subsection 27(2) of the regulations to change the deadline date from September 15 to August 1. This change is necessary for education authorities to submit their capital construction requests to the department with sufficient time for the department to receive the information and to submit the department’s needs to the Treasury Board.

SECTION 2 provides for the commencement of these regulations.
