ESTIMATES OF CAPITAL EXPENDITURE
FISCAL YEAR 2022-2023

This Council in Committee, having under consideration the Estimates of Capital Expenditure required to carry on the Public Service of the Province for the Fiscal Year ending March 31, 2023, and amounting in all to the sum of Two Hundred and Twelve Million, One Hundred and Five Thousand, Two Hundred Dollars (\$212,105,200), together with a sum sufficient for similar Capital expenditure, to carry on the Public Service of the Province from the expiration of the Fiscal Year ending March 31, 2023 up to and until the final passage of the Capital Estimates for the Fiscal Year ending March 31, 2024, it was and is hereby recommended that the Capital Estimates be approved by Her Honour, the Lieutenant Governor of the Province of Prince Edward Island, and be presented to the Legislative Assembly during the present session thereof.
