F-9, Council agreed to guarantee the payment obligation of the Prince Edward Island Housing Corporation in an amount not exceeding one million, nine hundred sixty-two thousand, one hundred fifty-five dollars and sixty-one cents (\$1,962,155.61) (hereinafter referred to as the "guaranteed indebtedness"), which said guarantee is provided as security for the guaranteed indebtedness arising from a claim of lien registered against lands owned by the Prince Edward island Housing Corporation, as contemplated under subsection 53(1) of the *Mechanics Lien Act* R.S.P.E.I. 1988, Cap. M-4, in the matter of NK Quality Restoration Inc., carrying on business as Strategic Enterprises, and Government of Prince Edward Island and Prince Edward island Housing Corporation (Court File No. S1-GS-29658), and pursuant to the Court Order in the said matter dated November 28, 2023.
