**DECISION**

**Background**

1. On 20 July 1999, the applicant filed with the Prince Edward Island Labour Relations Board, hereinafter referred to as the "Board", an Application for Revocation of Certificate Order 20-66, issued on the 24th day of May, 1966. The ground for Revocation stated in the Applicant's Form 7 is "That I do verily believe that the current members of the Union employed at Storey Electric Limited do not wish to be represented for collective bargaining purposes by the Respondent Union."

2. On 15 August 1999, the Respondent filed its Reply to the Application for Revocation of Certification in Form 10 and the basis for their opposition to the application is set out in Question 4 which states as follows:


*The Union has had discussions with the members of the union employed at Storey Electric and they have not said they do not wish to be represented by I.B.E.W. for bargaining purposes.*


3. At the request of one party and the consent of the other party, the Board postponed any hearing. On 22 November 1999, the Chief Executive Officer posted notice of a representation vote to be held on 26 November 1999.


4. On 26 November 1999, prior to the three employees of the Applicant casting their votes, the Applicant and the Respondent agreed they would abide by the results of the representation vote and a hearing on this application would not be required.

**Conclusion**


The results of the representation vote confirmed the three employees no longer wish the Union to act as bargaining agent on their behalf. In light of the foregoing, the Board concludes and orders that Certification Order 20-66 issued on the 24th day of May 1966 between the International Brotherhood of Electrical Workers - Local 1432 and Storey Electric Limited be revoked.
