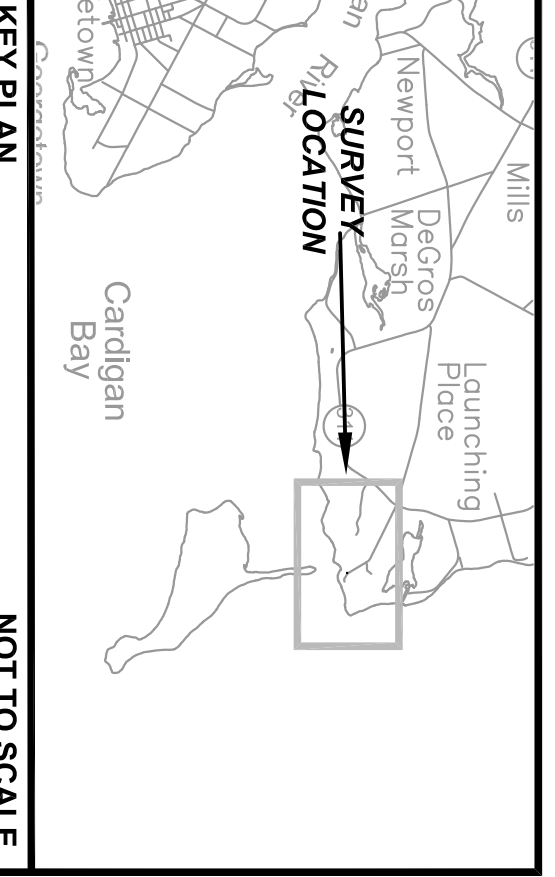

KEY PLAN NOT TO SCALE

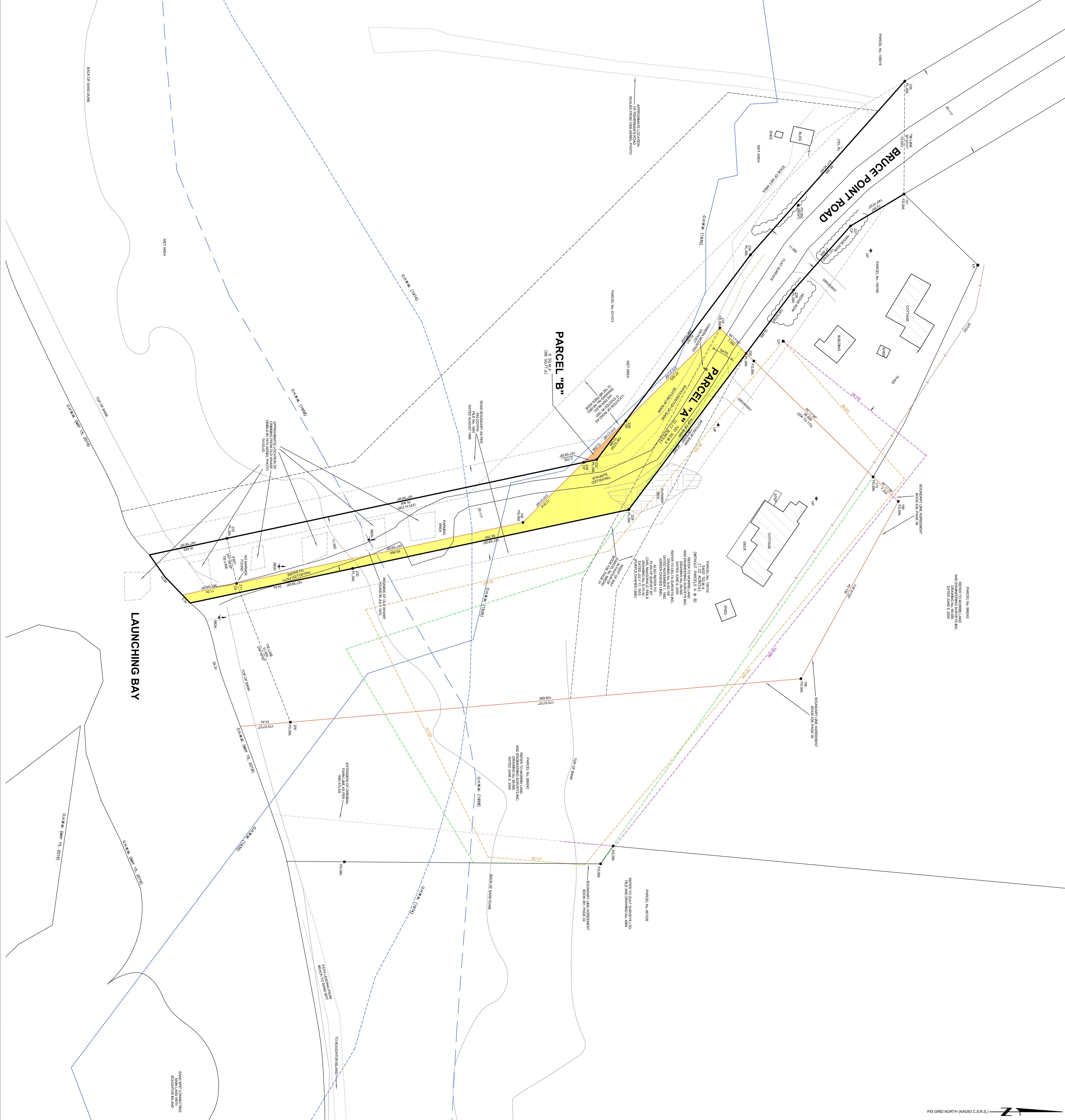
