



Customer Application for Energy Rebate

Instructions:

- The rebate is 10% of the cost (before HST) of purchases of electricity, propane (≥ 100 litres), wood pellets, and firewood (> 1 cord) for residential purposes;
- Claims must total \$50 or be submitted annually;
- The Application must be received within 12 months of the date of purchase;
- Completed Applications should be paid within 4 weeks;
- **Original invoices/receipts must be returned** with the Application and must include Supplier Trade Name, HST Number of the Supplier, Date of Purchase, energy purchased, amount paid before tax, HST paid and total amount;
- A vendor registration form must be included if the customer is not already registered;
- Please complete the entire form.
