



Energy Rebate Supplier Registration Form

- Instructions**
1. The Energy Rebate applies to Electricity, Propane (fixed tanks > 100 litres), Firewood (>1 cord per year) and Wood Pellets, used for residential purposes;
 2. In order to receive payment from the Department, the supplier must complete the attached vendor registration form, if one is not already on file. Suppliers who have received an electronic payment from the Province are likely registered;
 3. When invoicing customers, the invoice must be HST taxable and include all the information of a regular invoice, including your HST number;
 4. After the regular total, the invoice should have a line "PEI Government Energy Rebate" which will be 10% of the pretax invoice and will be deducted to come to the final invoice amount;
 5. To recover the 10% rebate, the Supplier Reimbursement Form should be completed and submitted to the Department no more frequently than monthly. Supporting invoices and reports are to be retained and available for audit purposes for 7 years;
 6. Payment will be issued within 30 days of receipt and verification;
 7. All invoices for the fiscal year ending March 31 must be received by April 15.
