6.0 BUSINESS ITEMS

6.1 CEO Report to Islanders

Dr. Michael Gardam, Health PEI CEO, provided a verbal CEO report to Islanders. Some highlights include:

- Our response to Hurricane Fiona was robust. Most services were back up after a few days, main issues were lack of power.
- Hillsborough Hospital and Garfield St Offices were damaged. Garfield is evacuated.
- Healthcare System we have historic issues that are planning to be addressed, some challenges are big ticket items. Treasury Board rules have slightly changed which enables Health PEI to make more decisions regarding budget useage.
- Pharmaplus Program we are trying to use every part of the healthcare system
 and often the local Pharmacist is the first face of accessible healthcare, we are
 paying Pharmacists for the work they are doing. Pharmacists have welcomed the
 program but unfortunately there is misinformation circulating

6.2 Board Chair Report

Mr. Derek Key, Health PEI Board Chair, welcomed the guests and provided a brief verbal report to the public.

- Mr. Key reiterated the importance of Human Resources is an ongoing issue, we require fundamental structural changes.
- Heartened by the efforts made by HR and the People Strategy, giving direction to how and what needs to be done, positive change
- We need to set out our priorities regarding the scope of practice, Nurse Practitioners and Pharmacists

9.0 QUESTION PERIOD

9.1 Local Stakeholder Questions

The Board held an open question period for all guests to participate in.

Ms. Bobbi Newman, a Health PEI worker for 22 years, addressed the Board, The Chair reminded her that at this level, we are not involved in Operational issues, and our understanding is that mediation is pending.

Ms. Newman firstly expressed her disappointment with the latest retention incentives that excluded Health care Support workers like herself. Secondly, she asked the Board to look into the mistreatment of staff that she felt was intrinsic within Health PEI. She encouraged Health PEI to look into her case which has been ongoing without resolution for 2 and a half years. She feels her harassment case has been proven and should not be heading to Arbitration. She also questions why there has been no consequences to anyone else, other than herself, the victim. She feels staff are leaving because of the poor treatment of staff. Mr. Derek Key thanked her for her time.

The Board Meeting was joined by representatives from the O'Leary Community Health Foundation, led by Ms. Eva Rogerson. The issues they addressed were as follows: -

- Island EMS & Storage Building the Foundation are looking to upgrade their depot/ storage facility in O'Leary. Dr. Gardam is not aware of the proposal and will look into it. He asked Ms. Rogerson to send an email with the details
- Ambulatory Care, second permanent position they would like the Board's support to engage a permanent nurse
- Retention of Physicians Ms. Rogerson asked whether Physicians take part in an Exit Survey. Dr. Gardam felt that we need a better negotiation structure to entice GPs to the island, however, the recent GPs standing down are not leaving Health PEI, they are moving to other positions. He has tasked his Chief Medical Officer to recommend a workplan to move away from disparities between east and west on the Island and combine roles to build resilience
- MAPLE anyone who does use the MAPLE system who does need to be examined is pre-booked into a local clinic
- Ultrasound Dr. Gardam asked Ms. Rogerson to email the details

Guests thanked the Health PEI Board allowing them to join today.
