


**Before you start:** You must use a computer/laptop. We suggest using Google Chrome or Firefox as the browser.

**Step 6**  
Retrieve your Draft  
→ If you have saved a draft the blue box entitled Draft Services will show at the top of your business account page.  
→ Click *Continue* – if you want to start from your last saved draft  
→ Click *Delete* – if you want to delete your last saved draft. This will allow you to start over.  
→ Drafts are only saved for 30 days. Your business account page will show the date the draft will be deleted.

If you didn't click *Save Draft* while completing your application, you will be unable to retrieve your draft.
