Under subsection 2.(7) of the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap N-3, the Prince Edward Island Marketing Council makes the following Order:

PRODUCER CLASS 1 MILK PRICE DETERMINATION ORDER

Application 1. This Order establishes the producer price of Class 1 milk components to be paid to Dairy Farmers of Prince Edward Island by milk processors for milk sold in Class 1 milk products.

Classifications 2. The milk classifications that apply in this Order shall be established by the Dairy Farmers of Prince Edward Island, by Order of the Classification of Milk Order No. DFPEI2005-02.

Class 1(a)
component prices 3. The price of milk components paid to the Dairy Farmers of Prince Edward Island by processors for components sold in Class 1(a) products shall be \$7.3661 per kilogram of butterfat, \$6.7306 per kilogram of protein and \$6.7306 per kilogram of other solids. The Dairy Farmers of Prince Edward Island shall use a standard component test value of 3.3706 kilograms per hectolitre for protein and 5.7697 kilograms per hectolitre of other solids for billing purposes.

Class 1(b)
component prices 4. The price of milk components paid to the Dairy Farmers of Prince Edward Island by processors for components sold in Class 1(b) products shall be \$7.3661 per kilogram of butterfat, \$6.5743 per kilogram of protein and \$6.5743 per kilogram of other solids. The Dairy Farmers of Prince Edward Island shall use a standard component test value of 2.7890 kilograms per hectolitre for protein and 4.7783 kilograms per hectolitre of other solids for billing purposes.

Class 1 (b)(ii)
component prices 5. The price of milk components paid to the Dairy Farmers of Prince Edward Island by processors for components sold in Class 1(b)(ii) products shall be the prices for those components established by the Canadian Dairy Commission. The Dairy Farmers of Prince Edward Island shall use a standard component test value approved by Marketing Council for billing purposes.

Class 1(c)
component prices 6. The price of milk components paid to the Dairy Farmers of Prince Edward Island by processors for components sold in Class 1(c) products shall be 15% less than the prices of similar milk components used by processors for products sold in Class 1(a) and Class 1(b) products where Dairy Farmers of Prince Edward Island has approved Class 1(c) products during an introductory period. The Dairy Farmers of Prince Edward Island shall use a standard component test value approved by Marketing Council for billing purposes.

Class 1(d)

component prices 7. The price of milk components paid to the Dairy Farmers of Prince Edward Island by processors for components sold in Class 1(d) products shall be the prices for those components established by the Canadian Dairy Commission. The Dairy Farmers of Prince Edward Island shall use a standard component test value approved by Marketing Council for billing purposes.
