**EC2008-552**

**NATURAL PRODUCTS MARKETING ACT**  
**HOG COMMODITY MARKETING REGULATIONS**  
**AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated 10 September 2008.)

Pursuant to section 29 of the *Natural Products Marketing Act* R.S.P.E.I. 1988, Cap. N-3, Council made the following regulations:

**1. Section 15 of the *Natural Products Marketing Act* Hog Commodity Marketing Regulations (EC275/76) is amended**

**(a) by renumbering it as subsection 15(1); and**

**(b) by the addition of the following after subsection (1):**

(2) Notwithstanding subsections 8(2) and 15(1), where no registered producer in a county is willing or able to serve on the board, the Council may appoint a registered producer from another county to serve on the board to fill the unexpired term of office of the member being replaced, or until the date of the next election. Exception

**2. These regulations come into force on September 20, 2008.**

**EXPLANATORY NOTES**

**SECTION 1** provides that where a registered producer from a county is unwilling or unable to serve on the board, the Council may, pursuant to this amendment, appoint a registered producer from another county to the board to fill the unexpired term of office of the member being replaced, or until the date of the next election.

**SECTION 2** provides for the commencement of these regulations.

**EC2008-554**

**SCHOOL ACT  
STUDENTS AND PARENTS REGULATIONS  
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated 10 September 2008.)

Pursuant to section 147 of the *School Act* R.S.P.E.I. 1988, Cap. S-2.1, Council made the following regulations:

**1. Section 1 of the *School Act* Students and Parents Regulations (EC69/96) is amended**

**(a) by the revocation of subsection (1) and the substitution of the following:**

Age six for  
enrolment purposes

**1.** (1) A person who reaches the age of six years on or before the date in a school year specified below may be enrolled in a school in September of that school year:

- (a) for the school year commencing September 1, 2008 and ending on June 30, 2009, the date is October 31;
- (b) for the school year commencing September 1, 2009 and ending on June 30, 2010, the date is October 31;
- (c) for the school year commencing September 1, 2010 and ending on June 30, 2011, and for any school year thereafter, the date is December 31.

**(b) in subsection (2), by the addition of the words “other than a private school,” after the words “may be enrolled in a school,”; and**

**(c) by the addition of the following after subsection (2):**

*Idem*

(2.1) No person under the age of six years may be enrolled in a private school, unless

- (a) the person may be enrolled in a private school under subsection (1);
- (b) the person within six months before seeking enrolment in a private school in the province,
  - (i) was enrolled in a formal school program in another jurisdiction, and
  - (ii) received regular progress assessments from the administrator of the formal school program in the other jurisdiction that are provided and acceptable to a private school inspector appointed under section 135 of the Act; or

(c) the person's date of birth cannot be determined and the person is assessed as being school-ready by a private school inspector appointed under section 135 of the Act.

**2. Section 2 of the regulations is revoked and the following substituted:**

**2.** A person who reaches the age of seven years on or before the date in a school year specified below shall be enrolled in a school in September of that school year:

- (a) for the school year commencing September 1, 2008 and ending on June 30, 2009, the date is October 31;
- (b) for the school year commencing September 1, 2009 and ending on June 30, 2010, the date is October 31;
- (c) for the school year commencing September 1, 2010 and ending on June 30, 2011, and for any school year thereafter, the date is December 31.

**3. These regulations are deemed to have come into force on September 1, 2008.**

**EXPLANATORY NOTES**

**SECTION 1** establishes that a person who reaches the age of six years on or before the specified date for the school year may be enrolled in a school for that school year. The amendment also provides for persons under the age of six years to be enrolled in a school in the specified circumstances.

**SECTION 2** establishes that a person who reaches the age of seven years on or before the specified date for the school year shall be enrolled in a school for that school year.

**SECTION 3** provides for the commencement of these regulations.
