Under the Dairy Farmers of Prince Edward Island Regulations and under the *Natural Products Marketing Act*, R.S.P.E.I.1988, Cap. N-3, Dairy Farmers of Prince Edward Island makes the following Order:

**SALEABLE QUOTA LIMITATION ORDER**

## Application

1. This Order establishes a limit on the amount of quota that dairy producers may sell, transfer or assign.

## Definitions

2. The words herein shall have the meanings as found in the Prince Edward Island Natural Products Marketing Act and the Dairy Farmers of Prince Edward Island Regulations unless differentiated herein and as hereinafter defined:
  - (a) "quota" means a producer's share of the market for milk products as determined by the Board and assigned to a producer by the Board.
  - (b) "saleable quota" shall mean quota in which producers are deemed to hold rights that they may sell or otherwise transfer to other producers.
  - (c) "non-saleable quota" shall mean quota in which producers do not hold rights that they may sell, transfer or assign to any person.

## Limit on Saleable Quota

3. Saleable quota issued in PEI shall be limited to a maximum amount equal to the all provincial and federal quota allocated to the province of Prince Edward Island as of 1 August 2009.

## Calculation of Maximum Saleable Quota

4. For the purpose of calculating the quota allocated to Prince Edward Island as of 1 August 2009, it shall be deemed to include the market sharing quota, the fluid milk quota reference and an estimate for quota allocated under the Domestic Dairy Product Innovation Program, which together is calculated to equal 10,675.5 Kg of daily quota.

## Non-Saleable Quota

5. Any quota issued in Prince Edward Island above the limit specified in Paragraph 4 (above) shall be non-saleable quota.

## Non-Saleable Quota Attached to Saleable Quota

6. Any non-saleable quota issued to a producer shall be attached to saleable quota in such a manner that the sale or transfer of saleable quota shall result in the transfer of a corresponding portion of non-saleable quota.

7. Any decrease in the total quota issued to PEI producers below the maximum saleable quota amount stated in paragraph 4 (above) shall be removed proportionally from producers' saleable quota. Any subsequent increase in saleable quota issued to PEI producers, shall be distributed to producers proportionally to their share of issued quota prior to that increase.

8. This Order comes into force on the 25th day of August 2009.

#### EGG MARKETING, GRADES AND STANDARDS ORDER

Application

1. This order establishes the grades, standards and terms and conditions under which eggs may be marketed in Prince Edward Island.

Interpretation

2. The meaning of the words herein shall be as defined in the Natural Products Marketing Act and the Egg Commodity Marketing Regulations unless differentiated herein and as hereinafter defined:
  - (a) "Board" means the Egg Producers of Prince Edward Island;
  - "candling" means examining the interior condition of an egg by rotating or causing the egg to rotate in front of or over a light source that illuminates the contents of the egg;
  - (b) "carton" means a package that is made to contain not more than 30 eggs in separate compartments;
  - (c) "consumer" means a person who buys eggs for use by himself or his household and not for resale;
  - (d) "container" means any case, box, carton or other receptacle made to contain eggs;
  - (e) "cracks" means eggs that have the following characteristics:
    - (i) the eggs are clean, and the internal contents are not leaking, and
    - (ii) on candling, the egg meets the standard for at least Canada C;

- (f) "direct sales" means sale of eggs from a producer directly to a consumer;
- (g) "egg product" means frozen egg, liquid egg, or dried egg;
- (h) "grade eggs" means to mark eggs with one of the terms specified in subsection 3(2);
- (i) "process" means any part of the work of preparing egg product;
- (j) "producer" means a person who produces eggs and who ships, transports or sells only eggs produced on his own farm;
- (k) "registered egg grading station" means a place where eggs are prepared, graded or marked, and in respect of which a certificate of registration has been issued under the Egg Regulations pursuant to the Canada Agricultural Products Act;
- (l) "registered egg processing station" means a place in which processed egg product is prepared, graded and marked, and in respect of which a certificate of registration has been issued under the Processed Egg Regulations pursuant to the Canada Agricultural Products Act;
- (m) "reject" means any egg that does not meet the requirements of any of the terms specified in subsection 3(2) or that has been in an incubator;
- (n) "retailer" means a person who offers, has in its possession for sale or sells eggs, directly to a consumer;
- (o) "ungraded egg" means eggs in containers which are not marked with one of the terms specified in subsection 3(2); and
- (p) "wholesaler" means any person other than a producer who sells eggs to
  - (i) a retailer,
  - (ii) any person in quantities of fifteen dozen or more for use as food or in the preparation of food, or
  - (iii) a registered egg processing station.

### EXPLANATORY NOTES

- wind energy conversion systems with a generating capacity of less than 50kw; and
- non-commercial or non-industrial agricultural buildings of 10,000 sq. ft. or greater.

**SECTION 2** provides for the commencement of these regulations.
