TO ALL TO WHOM these presents shall come or whom the same may in any wise concern:

**GREETING
A PROCLAMATION**

WHEREAS in and by section 43 of Chapter 5 of the Acts passed by the Legislature of Prince Edward Island in the 3rd Session thereof held in the year 2009 and in the fifty-eighth year of Our Reign intituled "Employment Standards Amendment Act, 2009" it is enacted as follows:

"This Act comes into force on a date that may be fixed by proclamation of the Lieutenant Governor in Council."

AND WHEREAS it is deemed expedient that all sections except section 8 of the said Act, Stats. P.E.I. 2009, 3rd Session, c. 5 should come into force on the 1st day of October 2010,

NOW KNOW YE that We, by and with the advice and consent of our Executive Council for Prince Edward Island, do by this Our Proclamation ORDER AND DECLARE that all sections except section 8 of the said Act being the "Employment Standards Amendment Act, 2009" passed in the fifty-eighth year of Our Reign shall come into force on the first day of October, two thousand and ten of which all persons concerned are to take notice and govern themselves accordingly.

IN TESTIMONY WHEREOF We have caused these Our Letters to be made Patent and the Great Seal of Prince Edward Island to be hereunto affixed.
