**PUBLIC HEALTH ACT**  
**EATING ESTABLISHMENTS AND**  
**LICENSED PREMISES REGULATIONS**  
**AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated 23 November 2010.)

Pursuant to section 23 of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30, Council made the following regulations:

**1. The *Public Health Act* Eating Establishment and Licensed Premises Regulations (EC16/79) are amended**

**(a) in section 1 by addition of the following after clause (j):**

(j.1) “low risk food” means food that is unlikely to contain pathogenic micro-organisms or toxins or will not support the growth of pathogenic micro-organisms or the production of toxins; low- risk food

**(b) by the addition of the following after section 1.1:**

**1.2** These regulations do not apply in respect of a private residence where low-risk food is prepared for sale or sold to the public as part of a non-commercial activity. Application re private residences

**2. These regulations come into force on December 4, 2010.**

**EXPLANATORY NOTES**

**SECTION 1** adds a definition for “low risk food” and adds a provision exempting a private residence from the application of the regulations in certain circumstances.

**SECTION 2** provides for the commencement of these regulations.
