(a) A levy on ungraded eggs shall be assessed annually by the Board on each producer, subject to change by the Board, and the levy shall be based on the producer's allocated quota at the rate of thirty six point six zero cents (\$0.3660) per dozen eggs, plus applicable provincial and federal taxes, and it is established that the number of eggs per bird for levy calculation purposes shall be twenty five point four, four (25.44) dozen eggs per annum except that during a year that has fifty-three (53) weeks the number of eggs per bird shall be twenty-five point nine three (25.93) dozen eggs per annum.
