Under the *Natural Products Marketing Act*, R.S.P.E.I.1988, Cap. N-3, and the Dairy Farmers of Prince Edward Island Regulations thereunder, Dairy Farmers of Prince Edward Island makes the following Order:

**FLUID MILK COMPOSITIONAL STANDARDS**

Definitions

1. This order applies to the compositional standards of fluid milk products.
2. In this Order,
  - (a) "board" means Dairy Farmers of Prince Edward Island;
  - (b) "bulk milk grader" means a person licensed by the Board to perform the duties of a bulk milk grader as described in the Raw Milk Production and Transportation Order of the Board and who holds a bulk milk grader's license issued by the Board;
  - (c) "consumer" means an individual who is acting other than in the course of carrying on business;
  - (d) "dairy animal" means a cow of the bovine family kept for the purposes of milking;
  - (e) "DFPEI" means Dairy Farmers of Prince Edward Island;
  - (f) "distributor" means a person engaged in selling or distributing fluid milk products directly or indirectly to consumers, and for better certainty includes a processor, but does not include a storekeeper;
  - (g) "fluid milk product", also called "class 1 milk product" means any product made from milk or cream that is prepared for sale in liquid or fluid form;
  - (h) "inspector" means a person who is a bulk milk grader and who is appointed by the Board to, subject to the provisions of this Order, detain or seize and dispose of any product marketed by a person as a fluid milk product that is determined not to be a fluid milk product as defined in this Order.
  - (I) "milk" means a normal lacteal secretion obtained from the mammary gland of a dairy animal that has not been modified in any way other than by the removal of milk fat and homogenization;
  - (j) "official method" means a method of analysis or examination approved by the Board for use in the administration of this Order;
  - (k) "omega-3 polyunsaturated fatty acids" means "omega-3 polyunsaturated fatty acids" as defined in article B.01.001 of the Food and Drug Regulations made under the Food and Drugs Act (Canada).

Raw milk standards

3. Milk that meets the standards established in the Raw Milk Production and Transportation Board Order of the Board is designated for use in the manufacture of <http://www.gov.pe.ca/royalgazette>

Reconstituted milk fluid milk products.

4. Milk that is,

- (1) derived in whole or in part from a milk product, and
- (2) resembles or may be used as a substitute for a fluid milk product is designated as reconstituted milk.

Not reconstituted milk 5. A fluid milk product with increased milk solids is not reconstituted milk.

*Idem* 6. The provisions of this Order applying to reconstituted milk do not apply to reconstituted milk processed at home for consumption on the premises.

Designated fluid milk products 7. The following products are designated as fluid milk products:

- (1) Products processed from milk that contain no oil or fat other than milk-fat.
- (2) Products, other than milk beverages and the products described in subsection (1), if the products are processed from milk and contain,
  - (a) no more than 0.5 per cent by weight of oil or fat other than milk-fat when contained in a flavouring agent, and
  - (b) no fat or oil other than milk-fat, except for the oil or fat mentioned in subparagraph (a).
- (3) A milk beverage that contains,
  - (a) no more than 0.5 per cent by weight of oil or fat other than milk-fat when contained in a flavouring agent,
  - (b) in addition to the oil or fat mentioned in subparagraph (a), no more than 0.5 per cent by weight of oil or fat other than milk-fat, if the oil or fat contains omega-3 polyunsaturated fatty acids and its inclusion in the milk beverage would allow a person to make a nutrient content claim that the milk beverage is a source of omega-3 polyunsaturated fatty acids, and
  - (c) no fat or oil other than milk-fat, except for the oil or fat mentioned in subsections (1) or (2).
- (4) Products reprocessed from a product described in subsections 1, 2 or 3.

*Idem* 8. Notwithstanding S.7, fluid milk products may include, but are not limited to: blend, buttermilk, cream, double cream, eggnog, flavoured cream, flavoured milk, flavoured partly-skimmed milk, flavoured skim-milk, milk beverages, partly-skimmed milk, skim-milk, standard milk, table cream and whipping cream.

Fluid milk product standards 9. Fluid milk products shall only contain milk that meets the standards set out in the Raw Milk Production and Transportation Board Order of the Board.

- (1) In addition,
  - (a) blend cream
    - (I) shall contain not less than 10 per cent and not more than 16 per cent milk-fat, and
    - (ii) may contain added pH adjusting agents and stabilizers;
  - (b) buttermilk,
    - (I) shall be prepared by adding a bacterial culture to milk from which a portion of the milk-fat has been removed so that it develops an acidity in excess of that found in milk,
    - (ii) shall contain not more than 3.25 per cent milk-fat, and
    - (iii) may contain added salt and stabilizers;

Buttermilk

Double cream (c) double cream,  
 (I) shall contain not less than 40 per cent milk-fat, and  
 (ii) may contain added pH adjusting agents and stabilizers;

Eggnog (d) eggnog,  
 (I) shall contain not less than 3.9 per cent and not more than 6.1 per cent milk fat and not less than 9 per cent milk solids other than fat, and  
 (ii) notwithstanding S.7, may contain added sugar, sweeteners, emulsifiers stabilizers and flavouring agents, including ingredients derived from milk products, to a maximum of 10 per cent milk solids other than fat;

Flavoured cream (e) flavoured cream,  
 (I) shall contain not less than 10 per cent milk-fat, and  
 (ii) may contain added flavouring, salt, pH adjusting agents, stabilizers, sweeteners and food colouring;

Flavoured milk (f) flavoured milk,  
 (I) shall contain not less than 3 per cent milk-fat, and  
 (ii) may contain added flavouring, salt, stabilizers, sweeteners, food colouring and vitamins A and D;

Flavoured partly-skimmed milk (g) flavoured partly-skimmed milk,  
 (I) shall contain not less than 0.9 per cent and not more than 1.1 per cent milk-fat or not less than 1.9 per cent and not more than 2.1 per cent milk-fat, and  
 (ii) may contain added flavouring, salt, stabilizers, sweeteners, food colouring and vitamins A and D;

Light eggnog (h) light eggnog,  
 (I) shall contain not less than 2.9 per cent and not more than 3.1 per cent milk fat and not less than 10 per cent milk solids other than fat, and  
 (ii) notwithstanding S.7, may contain added sugar, sweeteners, emulsifiers stabilizers and flavouring agents, including ingredients derived from milk products, to a maximum of 10 per cent milk solids other than fat; and

Flavoured skim-milk (i) flavoured skim-milk,  
 (I) shall contain not more than 0.3 per cent milk-fat and not less than 8 per cent milk solids other than milk-fat, and  
 (ii) may contain added flavouring, salt, stabilizers, sweeteners, food colouring and vitamins A and D;

Standard milk (2) Subject to S.7, standard milk,  
 (a) shall contain not less than 3.15 per cent and not more than 3.35 per cent milk fat,  
 (b) shall contain not less than 8 per cent milk solids other than milk-fat, and  
 (c) may contain added vitamin D;

Milk beverage (3) A milk beverage,  
 (a) shall contain not less than 51 per cent by volume of milk, partly-skimmed milk or skim-milk, and  
 (b) may contain added fruit, fruit pulp, fruit juices, vegetables, vegetable pulp, vegetable juices, nuts, carbon dioxide, bacterial cultures, salt, pH adjusting agents, stabilizers, sweeteners, lactase, flavouring and food colouring;

Partly-skimmed milk

(4) Partly-skimmed milk,

- (a) shall contain not less than 0.9 per cent milk-fat nor more than 1.1 per cent milk-fat and not less than 8.5 per cent milk solids other than milk-fat, or
- (b) shall contain not less than 1.9 per cent nor more than 2.1 per cent milk-fat and not less than 8.25 per cent milk solids other than milk-fat, and
- (c) may contain added vitamin A and vitamin D;

Skim milk

(5) Skim-milk,

- (a) shall contain not more than 0.3 per cent milk-fat and not less than 8.5 per cent milk solids other than milk-fat, and
- (b) may contain added vitamin A and vitamin D;

Table cream

(6) Table cream,

- (a) shall contain not less than 16 per cent but less than 32 per cent milk-fat, and
- (b) may contain added pH adjusting agents and stabilizers;

Unhomogenized milk

(7) Unhomogenized milk shall contain not less than 3.8 per cent milk-fat and not less than 8.25 per cent milk solids other than milk-fat if it is sold or processed for sale to a consumer in a container of 20 litres or more containing no internal gradations; and

Whipping cream

(8) Whipping cream,

- (a) shall contain not less than 32 per cent but less than 40 per cent milk-fat, and
- (b) may contain added pH adjusting agents and stabilizers.

Lactase

10. Lactase may be added to flavoured milk, flavoured partly-skimmed milk, flavoured skim-milk, standard milk, partly-skimmed milk or skim-milk.

Increasing milk solids

11. A fluid milk product with increased milk solids shall be prepared,

- (1) by adding Grade Canada 1 skim-milk powder, or evaporated or concentrated skim-milk, or both, to buttermilk, flavoured partly-skimmed milk, flavoured skim-milk, milk beverages, standard milk, partly-skimmed milk or skim-milk; or
- (2) by removing water from buttermilk, flavoured partly-skimmed milk, flavoured skim-milk, milk beverage, standard milk, partly-skimmed milk or skim-milk,
  - (a) except in the case of a milk beverage, the fluid milk product obtained under subsection (1) shall contain at least 10 per cent milk solids other than milk-fat.

Production and manufacturing of fluid milk products

12. During production or manufacture of a fluid milk product, no person shall,

- (1) add to the fluid milk product any substance that this Order does not require or permit; or
- (2) remove from a fluid milk product any substance, except milk-fat or water to the extent required or permitted by this Order.

Products deemed for sale

13. A fluid milk product having a composition other than as permitted by this Order, that is found on the premises of a manufacturer, wholesaler or retailer, shall be deemed to be for sale if it is,

- (1) packaged in consumer-sized containers; or

Detention of products

(2) in bulk or in containers other than consumer-sized containers and is not labelled "Not for Sale".

14. (1) If a fluid milk product has been manufactured or sold in contravention of this Order, an inspector may detain the product at the risk and expense of the person in possession of it.

Detention tag

(2) An inspector who detains a fluid milk product shall attach to the container or package of containers a detention tag and deliver or send by registered mail on the day of detention a notice of the detention to,

(a) the person in possession of the product; and

(b) the manufacturer, if any, whose name or number appears on the container or package of containers.

*Idem*

15. No person shall,

(1) offer for sale, sell, or move a detained product; or

(2) remove a detention tag.

Apply for release of product

16. (1) The person in possession of the product or the manufacturer may apply to the Board for release of the product from the detention.

Application

(2) An application under subsection (1) must contain a statement of the facts and reasons on which the applicant relies and must be received by the Board not later than 10 days after the detention was made.

Removal of detention tag

17. (1) If the Board is satisfied, without a hearing, that the product under detention was not manufactured or sold in contravention of this Order, the inspector shall remove the detention tag and release the product.

Board hearing

(2) If the product is not released from detention under subsection (1), the Board shall hold a hearing as soon as reasonably possible to determine whether there has been a contravention of this Order.

Product disposal or release

(3) If, after a hearing, the Board determines that the product under detention was,

(a) manufactured or sold in contravention of this Order, the Board may order that the product be disposed of; or

(b) not manufactured or sold in contravention of this Order, the Board shall order that the detention tag be removed and the product be released from detention.

Commencement

18. This Order comes into force on the 1st day of August 2012.

**AMENDMENTS TO REGULATIONS  
TO THE  
*LEGAL PROFESSION ACT***

**The existing Regulation 17.1 is replaced with the following:**

17.1 (1) A member of the Barreau du Québec or the Chambre des notaires du Québec may apply for admission on transfer as a Canadian Legal Advisor by delivering to the Secretary-Treasurer the following:

- (a) a completed application for admission for transfer as a Canadian Legal Adviser in the prescribed form, including a personal questionnaire and written consent for the release of relevant information to the Society;
- (b) has filed two certificates of good character in the prescribed form from members in good standing of this Society or of a law society or comparable body of which the applicant is a member, or from judges of the Superior Court of Record in the jurisdiction of such society or body;

(c) has filed a certificate of standing satisfactory to the Council from the appropriate officer of the Barreau du Québec or the Chambre des notaires du Québec, and every Law Society of which the applicant is a member certifying

- (i) that the applicant is a member in good standing of that governing body;
- (ii) that no complaint is pending against the applicant for which the applicant could be struck off the roll, suspended or reprimanded;
- (iii) that the applicant has not been the subject of any previous disciplinary action by that governing body or, if the each other body regulating the legal profession, in any jurisdiction, in which the applicant is or as been a member of the legal profession;
- (d) has paid the prescribed fees; and
- (e) has complied with any condition prescribed by the Council.

(2) Upon the applicant complying with subsection (1), the Council shall determine whether the applicant is a fit and proper person to be admitted to the bar as a Canadian Legal Advisor and shall grant or refuse such admission accordingly.

(3) This Regulation does not apply to a member of the Barreau of Québec or the Chambre des notaires du Québec unless he or she has earned a bachelor's degree in civil law in Canada or a foreign degree and a certificate of equivalency from the Barreau of Quebec or the Chambre des notaires du Québec.

(4) A Canadian Legal Advisor who is a member of the Barreau du Quebec may

- (a) give legal advice on
  - (i) the law of Quebec and matters involving the law of Quebec,
  - (ii) matters under federal jurisdiction, or
  - (iii) matters involving public international law,
- (b) draw, revise or settle a document for use in a proceeding concerning matters under federal jurisdiction or
- (c) appear as counsel advocate before any tribunal with respect to matters under federal jurisdiction.

(4.1) A Canadian Legal Advisor who is a member of the Chambre des notaires du Québec may:

- (a) give legal advice and consultation on legal matters involving the law of Québec or involving matters under federal jurisdiction or public international law,
- (b) prepare and draw up a notice, motion, proceeding or similar document intended for use in a case before a judicial or quasi-judicial body in a matter under federal jurisdiction where expressly permitted by federal statute or regulations,
- (c) plead or act before a judicial or quasi-judicial body in a matter under federal jurisdiction where expressly permitted by federal statute or regulations.

(5) A Canadian Legal Advisor must not engage in the practice of law except as permitted under subsection (4) and (4.1)

(6) A Canadian Legal Advisor has all the duties and responsibilities of a practising lawyer under the Act, these Regulations and the Code of Professional Conduct.

(7) A Canadian Legal Advisor must

- (a) be a member in good standing of the Barreau du Quebec or the Chambre des notaires du Québec authorized to practice law in the Province;

---

- (b) undertake to comply with subsection (5), and
- (c) immediately notify the Secretary-Treasurer in writing if he or she ceases to be authorized to practise law in Quebec.

(8) (a) A Canadian Legal Advisor may apply to the Secretary-Treasurer for exemption from the requirement to maintain professional liability insurance.

(b) On an application under subsection (a), the Secretary-Treasurer must grant the exemption, provided the Canadian Legal Advisor maintains the full mandatory professional liability insurance coverage required by the Barreau or the Chambre des notaires du Québec that extends to the lawyer's practice in this Society.

**New:**

112.1 (1) The Council may make mandatory continuing professional development policy requirements (in this part, the "policy").

(2) The Secretary-Treasurer may, with respect to any member who fails to comply with the policy,

- (a) refuse to issue a practising certificate to the member; or
- (b) give notice to the member that the member's practising certificate will cease to be valid and the member will be suspended upon the expiry of 30 days from the date of such notice unless the member complies with the policy.

(3) A member who has been suspended or to whom a practicing certificate has not been issued due to non-compliance with the policy, may apply to the Secretary-Treasurer for reinstatement:

- (a) by certifying completion of the minimum education requirements; and
- (b) by submitting the required fees.

(4) Members are responsible for retaining records of continuing professional development activities and to make the records available to the Law Society upon request.
