**HIGHWAY TRAFFIC ACT**  
**ADMINISTRATIVE DRIVING PROHIBITION AND VEHICLE**  
**IMPOUNDMENT REGULATIONS**  
**AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated January 26, 2016.)

Pursuant to section 312 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

**1. Form 1 of Schedule 4 to the *Highway Traffic Act* Administrative Driving Prohibition and Vehicle Impoundment Regulations (EC161/00) is amended under the heading “NOTICE”**

(a) **by the deletion of the words “for the second time within the last 2 years” and the substitution of the words “for the second time within the last 3 years”;** and

(b) **by the deletion of the words “for the third time within the last 2 years” and the substitution of the words “for the third time within the last 3 years”.**

**2. These regulations come into force on February 6, 2016.**

**EXPLANATORY NOTES**

**SECTION 1** amends Form 1 of Schedule 4 to the regulations to increase the time period within which previous contraventions of subsection 277.1(1) of the Act are counted as authorizing a 30-day or 90-day suspension of driving privileges from 2 years to 3 years. This change is necessary for consistency with recent amendments to the Act.

**SECTION 2** provides for the commencement of the regulations.
