**HIGHWAY TRAFFIC ACT
DEMERIT POINT SYSTEM REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated March 9, 2016.)

Pursuant to section 284 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

1. (1) Subsection 10(1) of the *Highway Traffic Act* Demerit Point System Regulations (EC1216/80) is amended by the addition of the words “or a safe driving course approved by the Registrar” immediately after the word “course”.

(2) Subsection 10(2) of the regulations is amended by the addition of the words “or a safe driving course approved by the Registrar” immediately after the word “course”.

2. These regulations come into force on March 19, 2016.

EXPLANATORY NOTE

SECTION 1 amends subsections 10(1) and (2) of the regulations, which currently authorize the deduction of three demerit points from a person's driving record upon the person successfully completing a Canada Safety Council driving course, to also authorize the deduction of three demerit points upon the successful completion of a safe driving course approved by the Registrar.

SECTION 2 provides for the commencement of these regulations.
