**LIQUOR CONTROL ACT
REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated March 22, 2016.)

Made by the Prince Edward Island Liquor Control Commission and approved by the Lieutenant Governor in Council under the *Liquor Control Act* R.S.P.E.I. 1988, Cap. L-14:

- 1. Subsection 50.7(1) of the *Liquor Control Act Regulations* (EC704/75) is amended by the deletion of the words “free-standing”.**
- 2. These regulations come into force on April 2, 2016.**

EXPLANATORY NOTES

SECTION 1 eliminates the requirement that a micro-brewery must be free-standing, which is not a prescribed licensing condition for either a winery or distillery.

SECTION 2 provides for the commencement of these regulations.
