 - (b) qualifications that the Council considers to be substantially equivalent to the requirements in clause (a).

EXPLANATORY NOTES

SECTION 1 amends the definition of “change of use” in subclause 1(1)(a.1)(i) of the *Roads Act* Highway Access Regulations (EC580/95) to delete the reference to a “garden suite” and replace it with a “supportive suite”. This amendment is required to authorize the placement of a temporary structure on a parcel of land. The amendment is necessary to coincide with recent amendments made to definitions in the *Planning Act* Subdivision and Development Regulations (EC693/00).

SECTION 2 amends SCHEDULE A-3, INFILLING AREAS, to the regulations to revoke a portion of Route 4 in Murray River since this portion of highway from Montague to Wood Islands has been reclassified to a collector highway.

SECTION 3 amends SCHEDULE B-1, COLLECTOR HIGHWAYS, to the regulations by revoking and replacing Route 131 to correct the directionality and Community names.

SECTION 4 amends SCHEDULE B-2, INFILLING AREAS, to the regulations by reclassifying portions of Route 6 in Stanley, from the roundabout to Douglas Road, and a portion of Route 4 in the Rural Municipality of Murray River and southward for approximately 530 metres, from collector highways to collector infilling areas. This will allow for more dense development within those portions of highways with a posted speed limit of 60 km/h or less.

SECTION 5 amends SCHEDULE C-1, LOCAL (CLASS 1) HIGHWAYS, to the regulations by revoking and substituting, revoking or adding to portions of the following roads described in the following amending subsections:

- 5(1) Route 131 in Richmond/Grand River/Arlington/Birch Hill – to correct the description.
- 5(2) Route 183 in Springhill/Enmore – this was misidentified as RI21019 instead of Route 183.
- 5(3) Revoking Route 226 (Darlington Road) – this is reclassified from C-1 to C-2 and RI21019 (MacArthur Road) as it is now Route 183.

SECTION 6 amends SCHEDULE C-2, LOCAL (CLASS 2) HIGHWAYS, to the regulations by revoking and substituting, revoking or adding to portions of the following roads described in the following amending subsections:

- 6(1) Route 226 in North Wiltshire/Greenvale – to correct the description to include reclassifying a portion (Darlington Road) from Local C-1 to Local C-2.

 - 6(15) Hurst Road in Clinton, was previously identified as the Richard Hurst Road.
 - 6(16) MacCormack Road in North St. Eleanors, now paved and listed in Schedule C-2.
 - 6(17) MacMillan Road in Five Houses, to correct the description.

- 8(23) Woodside Road in Clinton, to correct the description, since a portion is now paved.
- 8(24) Revoking the reference to RI33080 in Farmington, known as the School Road.

SECTION 9 amends SCHEDULE D-2, CLASS 2 SEASONAL HIGHWAYS, to the regulations by revoking and substituting the reference to the Goose River Road in Goose River River/Selkirk to redefine the starting point of the road as beginning at the intersection of RN 60079, Five Houses Road.

SECTION 10 provides for the commencement of the regulations.
