REGULATED HEALTH PROFESSIONS ACT
PHARMACIST AND PHARMACY TECHNICIAN
REGULATIONS
AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated March 22, 2022.)

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

1. Subsection 25(4.1) of the *Regulated Health Professions Act Pharmacist and Pharmacy Technician Regulations (EC445/19)* is amended by the deletion of the words “, during a public health emergency declared under the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30.1,”.

2. These regulations come into force on April 2, 2022.

EXPLANATORY NOTES

SECTION 1 amends subsection 25(4.1) of the regulations to authorize a pharmacist with special authorization to administer a COVID-19 vaccine by injection to a person between the ages of 12 and 18 at any time, not only during a public health emergency.

SECTION 2 provides for the commencement of these regulations.

EC2022-212**EMERGENCY MEDICAL TECHNICIANS ACT
EMERGENCY MEDICAL TECHNICIANS REGULATIONS
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated March 30, 2022.)

Pursuant to section 14 of the *Emergency Medical Technicians Act* R.S.P.E.I. 1988, Cap. E-6.11, Council made the following regulations:

1. The *Emergency Medical Technicians Act* Emergency Medical Technicians Regulations (EC532/13) are amended by the addition of the following after section 2:

Exception, exam
qualification

2.1 (1) Where an applicant for a license has not successfully completed the examination required by the Board in accordance with clause 6(2)(b) of the Act, the Board may issue a license to the applicant for a period of up to 12 months, on the condition that the licensee shall successfully complete the examination within the time specified by the Board.

Supervised practice

(2) Until the condition in subsection (1) is met, the licensee shall practise emergency medical technology only under the supervision of another licensee who holds a license at an equivalent or a higher level that is not subject to any conditions under this section or section 3.

2. These regulations come into force on April 2, 2022.

EXPLANATORY NOTES

SECTION 1 adds a new section 2.1 to the regulations, which provides for the Board to issue a license to an applicant who has not yet completed the examination required by the Board. The license is conditional on the licensee successfully completing the examination in the time required by the Board. Until then, the licensee is required to practise under supervision.

SECTION 2 provides for the commencement of these regulations.
