4. The amount of interest payable shall be calculated by multiplying one-half of the annual interest rate by the minimum balance on the ledger card or computer facsimile in the preceding six months.
5. Interest payable shall be calculated every six months, for the period from April 1 to September 30 and from October 1 to March 31.

 - (e.1) \$40 for communications in the judgment debtor’s household or, where there are more than two persons in the household, \$60 for communications for the household;
 - (e) **in clause (f), by the deletion of the words “\$150 for each person” and the substitution of the words “\$165 for each person”.**
2. **Subsection 2(3) of the Schedule to the regulations is amended by the deletion of the words “actual cost up to \$500” and the substitution of the words “actual cost up to \$525”.**
3. **These regulations come into force on May 11, 2024.**

EXPLANATORY NOTES

SECTION 1 updates the rates in the Schedule to the *Garnishee Act* Garnishee Regulations (EC84/23) to align the rates with the newly approved rates of financial assistance under the *Social Assistance Act* R.S.P.E.I. 1988, Cap. - (2) No fee is payable for the transfer of vehicle ownership (without a number plate attached) by a dealer with a Class A dealer's trade license, issued pursuant to the Dealer's Trade License Regulations (EC317/92).
2. **These regulations come into force on May 11, 2024.**

EXPLANATORY NOTES

SECTION 1 amends section 9 of the *Highway Traffic Act Fees Regulations*, which sets out certain service and document fees, to provide that no fee is payable by a dealer with a Class A dealer's trade license to transfer vehicle ownership (without a number plate attached).

SECTION 2 provides for the commencement of these regulations.

1. (1) **Form A in the Schedule to the *Jury Act Regulations* (EC431/92) is amended by the deletion of the words "to attend Her Majesty's Supreme Court" and the substitution of the words "to attend the Supreme Court".**
- (2) **Form A in the Schedule to the regulations is amended in section 4 of Part B by the deletion of the words "unless pardoned" and the substitution of the words "and a pardon has not been granted or a record suspension has not been ordered in respect of the offence under the *Criminal Records Act* (Canada)".**

EXPLANATORY NOTES

 - (c) recommencing at the intersection of Route 169 in the Rural Municipality of Tyne Valley to the intersection of Route 133 in the Rural Municipality of Central Prince; and
 - (d) recommencing at the intersection of Route 2 in the Community of West Devon to the intersection of Route 152 in the Town of Alberton.
 - (7) Route 13
 - (a) commencing at the intersection of Route 1 in the Rural Municipality of Crapaud to the intersection of Route 2 in the Rural Municipality of Hunter River; and
 - (b) recommencing at the intersection of Route 224 (east) in the Community of New Glasgow to the intersection of Route 6 in the Resort Municipality of Stanley Bridge, Hope River, Bayview, Cavendish and North Rustico.
 - (8) Route 15 commencing at the northern boundary of the City of Charlottetown, located approximately 310 metres south of the intersection of Route 221, to the boundary of Parks Canada property in the Community of Brackley Beach.
 - (9) Route 16 commencing at the intersection of MacPhee Avenue in the Town of Souris to the intersection of Route 16A in the Rural Municipality of Eastern Kings.

 - (17) Route 24 commencing at the intersection of Route 3 in the Community of Vernon River to the intersection of Route 4 in the Rural Municipality of Murray River.
 - (18) Route 25 commencing at the intersection of Route 2 in the Community of Marshfield to the intersection of Route 6 (east) in the Rural Municipality of North Shore.
 - (19) Route 107 commencing at the intersection of Route 2 in the Community of Norboro to the intersection of Route 1A in the Community of Wilmot Valley.
 - (20) Route 122 commencing at the intersection of Route 2 in the Community of Miscouche to the intersection of Route 12 in the Community of Southwest Lot 16.
 - (21) Route 124 commencing at the intersection of Route 2 in the Community of Wellington Centre to the intersection of Route 11 in the Rural Municipality of Abrams Village.
 - (22) Route 131 commencing at the intersection of Route 12 in the Community of Grand River to the intersection of Route 167 in the Community of Arlington.
 - (23) Route 152 commencing at the intersection of Route 12 in the Town of Alberton to the intersection of Route 155 in the Community of St. Louis.
 - (24) Route 153 commencing at the intersection of Route 152 in the Community of Montrose to the intersection of Route 2 in the Town of Tignish.
 - (25) Route 167 commencing at the intersection of Route 131 in the Community of Arlington Corner to the intersection of Route 169 in the Rural Municipality of Tyne Valley.
 - (26) Route 225 commencing at the intersection of Route 1A in the Community of Middleton to the intersection of Route 248 in the Rural Municipality of Warren Grove.

- (27) Route 248 commencing at the intersection of Route 1 in the Town of Cornwall to the intersection of Route 225 in the Rural Municipality of Warren Grove.
 - (28) Route 313 commencing at the intersection of Route 4 in the Town of Three Rivers to the intersection of Route 321 in the Community of Cardross.
 - (29) Route 321 commencing at the intersection of Route 2 in the Community of Morell East to the intersection of Route 313 in the Community of Cardross.
2. The following highways and parts of highways are designated as collector highways with effect from August 12, 1995:
 - (1) Route 6 commencing at the intersection of Route 258 in the Community of Rustico to the northern boundary of property number 641050 in the Town of North Rustico.
 - (2) Route 13 commencing at the intersection of Route 2 in the Rural Municipality of Hunter River to the intersection of Route 224 (east) in the Community of New Glasgow.
 - (3) Route 258 commencing at the intersection of Route 6 in the Community of Rustico to the intersection of Route 224 in the Community of New Glasgow.
 - (4) Route 315 commencing at the intersection of Route 1 in the Community of Wood Islands to the intersection of Route 4 in the Town of Three Rivers.
 3. The following highways and parts of highways are designated as collector highways with effect from August 25, 2012:
 - (1) Route 150, from the intersection of Route 2 in the Community of Elmsdale to the intersection of Route 12 in the Town of Alberton.
 4. The following highways and parts of highways are designated as collector highways with effect from May 14, 2022:
 - (1) Route 27 commencing at the intersection of Route 1 in the Rural Municipality of Clyde River to the intersection of Route 1 in the Town of Cornwall.
 5. The following highways and parts of highways are designated as collector highways with effect from November 26, 2022:
 - (1) Route 142 commencing at the intersection of Route 2 in the Community of Woodstock to the existing eastern boundary of the Town of O'Leary.
 6. The following highways and parts of highways are designated as collector highways with effect from March 23, 2024:
 - (1) Route 4 commencing at the intersection of Route 1 in the Community of Wood Islands to the intersection of Route 17 in the Town of Three Rivers.

SCHEDULE B-2**INFILLING AREAS**

1. The following portions of collector highways are designated for infilling pursuant to subsection 29(2) of these regulations:
 - (1) On Route 4
 - (a) that segment of highway that lies between the existing northern boundary of the Rural Municipality of Murray River and the southern boundary of PID 689364 in the Community of Murray River.
 - (2) On Route 6
 - (a) in the Community of Rustico, that segment of highway which lies between the intersection of Route 243 (east) and Route 243 (west);
 - (b) in the Community of Rustico, that segment of highway between the northern abutment of the Rustico Bridge and the southern boundary of the Town of North Rustico;
 - (c) that segment of highway which lies between the intersection of Route 224 and Route 254 in the Rural Municipality of Stanley Bridge, Hope River, Bayview, Cavendish and North Rustico and the intersection of RN 50092 in the Community of Stanley Bridge.
 - (3) On Route 7
 - (a) in the Community of Oyster Bed, that segment of highway which lies between the southern boundary of property number 746099 and the intersection of Routes 6 and 251.
 - (4) On Route 22
 - (a) in the Community of Mount Stewart, that segment of highway which lies between the northern boundary of property number 147215 and 60 metres south of the northern boundary of property number 1049691, a distance of 360 metres.
 - (5) On Route 25
 - (a) in the Rural Municipality of York, that segment of highway which lies between the southern boundary of property number 641415 and the southern boundary of the Confederation Trail.
 - (6) On Route 27
 - (a) in the Town of Cornwall, that segment of highway which lies between the intersection of Route 1 and the western boundary of property number 247874.

EXPLANATORY NOTES

SECTION 1 revokes Schedule B-1, Collector Highways, and substitutes a new Schedule B-1. The majority of changes are administrative in nature as many areas formerly identified as settlements are now referred to as Communities and some areas are now part of Rural Municipalities or Towns. There were also several Collector Highway sections that were formerly reclassified from Arterial Highways but the effective date of reclassification to Collector Highways was not correct, and these have been corrected. The section also revokes Schedule B-2, Infilling Areas, and substitutes a new Schedule B-2. Similar to Schedule B-1, the majority of changes are administrative, involving name changes and rearranging the order of the roads to ensure they are in numerical order. There are also two new additions or extensions in Infilling Areas, namely Route 6 in Stanley Bridge and Route 4 in Murray River.

SECTION 2 provides for the commencement of the regulations.
