    - (4) Notwithstanding subsections (2) and (3), where the benefit dispensed is a benefit designated in the formulary for which a co-payment not exceeding \$5.00 is payable, an eligible person is responsible for payment of the lesser of \$5.00 and the amount that would be payable under subsection (2) or (3).
- 5.(1) Clause 14(2)(b) of the regulations is revoked and the following substituted:**
- (b) the lesser of
    - (i) the applicable amount set out in Schedule B based on the eligible person’s household income, and
    - (ii) the remaining cost of the benefit.
- (2) Subclause 14(3)(a)(ii) of the regulations is revoked and the following substituted:**

- (ii) twenty per cent of the applicable amount set out in Schedule B based on the eligible person's household income; and

**SECTION 2** amends the name of the disease originally known as monkeypox to mpox.
