HEALTH AND DENTAL SERVICES COST ASSISTANCE ACT HEALTH AND DENTAL SERVICES COST ASSISTANCE REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated April 27, 2021.)

Pursuant to section 19 of the *Health and Dental Services Cost Assistance Act* R.S.P.E.I. 1988, Cap. H-1.21, Council made the following regulations:

- 1. Clause 10(a) of the *Health and Dental Services Cost Assistance Act* Health and Dental Services Cost Assistance Regulations (EC728/20) is revoked.
- 2. Clause 11(2)(c) of the regulations is revoked.
- 3. These regulations come into force on May 8, 2021.

EXPLANATORY NOTES

SECTION 1 revokes the definition of "formulary".

SECTION 2 revokes a clause including the cost of drugs listed on the formulary for the purpose of the fertility treatment program as a benefit of the program. The treatments described in clauses 11(2)(a) and (b) include drugs utilized in the treatments.

SECTION 3 provides for the commencement of these regulations.
