REGULATED HEALTH PROFESSIONS ACT
RESERVED ACTIVITIES REGULATIONS
AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated May 11, 2021.)

Pursuant to subsection 96(1) of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

1. The *Regulated Health Professions Act* Reserved Activities Regulations (EC536/15) are amended by the addition of the following after section 6:

7. For the purpose of subsections 86(3) and (4) of the Act, persons who have completed at least three years of a four-year bachelor's degree program in nursing are exempted in respect of administering a vaccine for the coronavirus causing the disease known as COVID-19, in the course of employment or a contract with the Government or Health PEI and under the supervision of a registered nurse who is physically present.

2. These regulations come into force on May 15, 2021.

EXPLANATORY NOTES

SECTION 1 exempts student nurses who have completed at least three years of a degree program in nursing from the prohibition against performing a reserved activity, in respect of administering the COVID-19 vaccine in the course of employment or a contract with the Government or Health PEI, under supervision.

SECTION 2 provides for the commencement of these regulations.
